All the representations were examined in detail and considered according to the merit and on the basis of the existing rules. Accordingly the provisional seniority list of Police Constables of Special Armed Police Bn as on 1.1.2015 published vide references cited is hereby finalized with the following changes.

1. **33** Police Constables,who were temporarily promoted to the cadre of Havildar during the year 2015 were not included in the provisional seniority list of police constables as on 01.01.2015.Accordingly they are also eligible for inclusion in the finalized list.

2. Serial No. 938 Sri. Rakesh R Nair, PC 12230 and SI No from 981 to 1093 have not completed 9 months basic training as on 01.01.2015.Hence they are excluded from the list.

3. **Sri.Arunkumar ,PC 10575 and Sri.Renjith.S.J , PC 10579** had been promoted as Havildar during the year 2014.Hence they are excluded from the list.

4.**Sri.Prasanth Kumar.Y.T PC 10951 and Sri.Gireesh ,PC 11012 and Sri.Abhilash ,PC 11601** , left department during the year 2014 and they were reappointed as PC only after 01.01.2015 , hence they are excluded.

5.**Sri.Deepu Das, PC 11302 and Sri.Deepu.S.S ,PC 11694** who were left department during the year 2014, hence the incumbents are not eligible for inclusion in the list.
