A Provisional Seniority list of Armourer Police Constables in Thiruvananthapuram Range as on 01/01/2017 was published vide this office order read as 1st paper above, in continuation of the finalised seniority list of Armourer Police Constables in Thiruvananthapuram Range for the period from 01.01.2002 to 20.02.2014, published vide this office order read as 2nd paper above.

All Unit heads concerned in Thiruvananthapuram Range were requested to circulate the same among the concerned and to forward complaints/suggestions, if any against the provisional seniority list to this office within 10 days from the date of publishing the list. Some complaints are received against the Provisional Seniority list within the stipulated period, as detailed below and all of them have been verified.

**Sri.Vijay.P, Armourer PC Q 6561, AR, Kollam.**

The petitioner has alleged that Sri.Ratheesh.L.R, Armourer PC 10311, who is junior to the petitioner as per the advice of Employment Exchange has been placed as senior to the petitioner in the Provisional Seniority list of Armourer Police Constables of Tvpmm Range as on 01/01/2017 and requested steps to correct the anomaly in this regard.

The same has been verified and being found eligible, necessary changes with regard to the seniority position of the petitioner have been made in the seniority list.

**Sri.Sreejith.V.L, Armourer PC T 4924, Police Chief Store, PHQ/**

**Sri.Binu.S, Armourer PC 5226, KAP III Bn, Adoor**

The petitioners have raised contention that as per the Provisional Seniority list of Armourer Police Constables of Tvpmm Range as on 01/01/2017, it is wrongly mentioned that they have not passed the Armourer basic training course. It is said that the petitioners have passed Armourer basic training course in the year 2014-15 as per BO No.278/2015 M dated 14/07/2015. Hence they have requested to rectify the error in this regard while finalising the provisional seniority list.

The same has been verified and being found correct, necessary changes have been made in the seniority list.

**Sri.Ratheesh.L.R, Armourer PC 10311, AR, Tvpmm Rural**

The petitioner has said that his General number in the Provisional Seniority list of Armourer Police Constables of Tvpmm Range as on 01/01/2017 is wrongly mentioned as 1311 instead of 10311 and requested to rectify the error in this regard.

The same has been verified and necessary changes have been made in the seniority list.

The Armourer Police Constables, namely, Sri.Prem P Rangan, 5227 and Sri.Shamnas.N.S, T 5210, mentioned in the Provisional Seniority list have been transferred to Ernakulam Rural & Kottayam, respectively, on inter-district transfer basis.



Accordingly their names are deleted in the finalised seniority list of Armourer Police Constables of Tvpm Range as on 01/01/2017.

In the above circumstances, the Provisional Seniority list of Armourer Police Constables of Thiruvananthapuram Range as on 01/01/2017, published vide this office order read as 1st paper above is hereby finalised with the changes as mentioned above and published as in the Annexure appended herewith. The finalisation of the seniority list is subject to the disposal of OP/OA/Writ Petitions, if any, pending before the Hon'ble Courts/KAT and Govt directions.

The unit heads concerned in Thiruvananthapuram Range will arrange to circulate the finalised seniority list among all the concerned forthwith.
