A finalised yearwise seniority list of Reserve Sub Inspectors of Police of Thiruvananthapuram Range for the period from 01.01.2002 to 31.03.2010 was published vide this office order No.A5/4343/2010/TR dated 19.09.2015. Based on the Range wise seniority lists, Statewide Combined Seniority list of RSIs of Police for the period from 01.01.2002 to 31.12.2009 was published from Police Headquarters vide Order No.L5/18616/2014 dated 09/12/2015. Later, finalised year wise Seniority list of RSIs of Police (Closed AR) of Thiruvananthapuram Range as on 01/01/2017 was published from this office, vide Order No.A5-14539/2017/TR dated 24.11.2017. As per the GO Cited 2nd, the personnel in regular ranks of Police Constables/ Head Constables/ Assistant Sub Inspectors/ Sub Inspectors in District Armed Reserve and General Executive Branch in Police districts were integrated to form a common cadre known as Kerala Civil Police Subordinate Service (KCP) w.e.f 01.04.2010.

In the Go cited 2nd, it is specified that, the date eligible for promotion of those personnel who opted to continue in the AR cadre w.e.f 01/04/2010 shall be determined, based on the Expected Date of Promotion (EDP) as on 01/04/2010 FN. But any post on higher rank, vacated by those of the AR cadre, who opt for serving in the KCP shall not be reckoned as vacancies in Closed AR for promotion. As such, the Seniority list of RSIs of Police (Closed AR) of Tvp Range for the period from 01/01/2010 onwards has been revised, based on the EDP calculated on the basis of the actual existing vacancy and a revised finalised Seniority list of RSIs of Police (Closed AR) of Tvp Range as on 01/01/2018 as per EDP (Expected Date of Promotion), was published vide this office order read as 1st paper above, after considering the petitions received against the provisional seniority list within the stipulated period and circulated among all the concerned.

Now, the State Police Chief, Kerala, vide reference read as 6th paper above has directed to publish Year wise Seniority list of RSIs of Police for the period from 01/01/2010 to 31/12/2017, in compliance with the directions from Police Headquarters, read as 2nd paper above.
