The State Wide Combined Seniority List of Reserve Sub Inspectors as on 01.01.2002 was finalized and published as per PHQ proceedings read as 2nd paper above. Thereafter a State Wide provisional seniority list of RSIs as on 01.01.2010 was published vide PHQ proceedings read as 4th paper above. Objections regarding this seniority list Were received and the same have been examined. In the meantime number of representations have been submitted by certain RSIs before Government and State Police Chief stating that, in the seniority list of RSIs in Thiruvananthapuram Range for the period from 01.01.1996 to 31.12.2001 there are certain anomalies such as no promotion and regularization have been done in certain retirement vacancies during the year 1999, 2000 and 2001. But in other Ranges regularization has done in Deputation, transfer vacancies etc which will result earlier promotion in other Ranges except in Thiruvananthapuram Range.

Kerala Police Officers Association vide reference read as 5th paper above has also pointed out these anomalies and requested to adopt a common criteria for preparing the Seniority list of RSIs.

All these issues were discussed in detail and it is decided to revise the seniority list of RSIs for the period from 01.01.1996 to 01.04.2010 based on the actual vacancies occurred against retirement, promotion, death, due to creation of temporary/permanent posts and left department.

As per GO(Ms) No.171/74 Home dated 18.11.1974, 50% posts of RSIs are earmarked for Direct Recruits through KPSC. But most of the Ranges prepare the seniority list without reserving sufficient number of vacancies to Direct Recruits. To make good the shortage in the 50% quota of posts for Direct Recruits, Range IsGP were directed to set apart sufficient number of vacancies arising in the Ranges from 01.01.2002 onwards to Direct Recruits. Thereafter regularization of Direct appointment/promotion shall be made against the vacancies arising in the posts of respective quota.

As such Inspector General of Police of the Ranges have furnished the Range wise seniority list of RSIs vide references read as 6th to 9th paper above adopting this criteria. In the circumstances, a Revised provisional State wide seniority list of Reserve Sub Inspectors for the period from 01.01.1996 to 01.04.2010 is published herewith .

All are requested to circulate the provisional seniority list from among all concerned within 10 days without fail. Objections, omissions and mistakes, if any, will be reported within 15 days from the date of publishing of the list. The officers concerned should forward the representations of the incumbents, if any, to PHQ through Ranges with specific remarks. If no objection is received within the time limit, it will be presumed that there are no objections against the seniority list and the provisional seniority list of RSIs will be finalized. Objections received after the expiry of the time limit shall not be entertained.
