A finalised seniority list of Assistant Sub Inspectors of Police in Armed Reserves Thiruvananthapuram Range as on 01/01/2017 was published vide this office order read as 1st paper above. As per the GO Cited 2nd, the personnel in regular ranks of Police Constables/Head Constables/Assistant Sub Inspectors/Sub Inspectors in District Armed Reserve and General Executive Branch in Police districts were integrated to form a common cadre known as Kerala Civil Police Subordinate Service (KCP) w.e.f 01.04.2010.

It is specified in the Go cited 2nd that, the date eligible for promotion of those personnel who opted to continue in the AR cadre w.e.f 01/04/2010 shall be determined, based on the Expected Date of Promotion (EDP) as on 01/04/2010 FN. But any post on higher rank, vacated by those of the AR cadre, who opt for serving in the KCP shall not be reckoned as vacancies in Closed AR for promotion. As such, the Seniority list of RASIs of Police (Closed AR) of Tvpm Range for the period from 01/01/2010 onwards has been revised, based on the EDP calculated on the basis of the actual existing vacancy and a revised Provisional Seniority list of RASIs of Police (Closed AR) of Tvpm Range as on 01/08/2017, as per EDP (for the vacancies from 01/01/2010 to 31/07/2017) is published herewith.

The unit heads concerned in Thiruvananthapuram Range are requested to circulate the seniority list among all the concerned forthwith and to forward complaints/suggestions, if any received against the provisional list within **10 days** from the date of publication of the list. If no complaints are received within the stipulated period, it will be presumed that there is no objections against the seniority list and the provisional seniority list of RASIs of Police (Closed AR) of Tvpm Range as on 01/08/2017 will be finalised accordingly.
