A provisional seniority list of Assistant Sub Inspectors of Police of Armed Reserves in Thiruvananthapuram Range as on 01/01/2015 was published vide this office order read as 1st paper above, based on the finalised seniority list of Head Constables of Thiruvananthapuram Range as on 01/04/2010, read as 2nd paper above. The unit heads concerned in Thiruvananthapuram Range were requested to circulate the seniority list among all the concerned and to forward complaints/suggestions, if any received against the provisional list within 10 days from the date of publishing the list. Some complaints were received against the provisional seniority list within the stipulated period as narrated below and all of them have been verified.

1) Sri.M.Shibabudeen, RSI of Police(Grade), AR, Tvpm City/ Sri.Venu.S, RSI (Grade), AR, Kollam City.

The petitioners have raised contentions that they have challenged the seniority list of Head Constables in Armed Reserves of Thiruvananthapuram Range, published on 01/04/2016, before the Hon'ble Kerala Administrative Tribunal. Hence the petitioners have requested to stop further proceedings with regard to the finalised seniority list of AR Head Constables of Thiruvananthapuram Range and provisional seniority list of RASIs of Police of Thiruvananthapuram Range, published vide this office Order No.A5-12/2013/TR dated 01/04/2016 and Order No.A5-5391/2016/TR dated 02/11/2016, respectively, based on the interim order of the Hon'ble Kerala Administrative Tribunal.

The Provisional Seniority list of RASIs of Police of Thiruvananthapuram Range as on 01/01/2015 is published, subject to the orders of the Hon'ble Kerala Administrative Tribunal with regard to the OAs, if any pending before the Tribunal. The seniority position of the police personnel included in the seniority list will be subject to revision/ recast based on the final orders of the Hon'ble Courts/Tribunal in this regard.

2) Sri.Anilkumar.R, ASI T 7393, AR, Tvpm City.

The petitioner has raised objection that he is not found included in the provisional seniority list and requested steps to include him.

On verification, it is found that the petitioner is eligible to be included in the seniority list. Hence the petitioner has been included in the seniority list as SI No.121 along with Sri.Sugathan ASI Q 4734 (SI No.111), Sri.Abraham, ASI T 8950 (SI No.81) and Sri.Jayasankar, ASI Q 4050 (SI No.83), who were also omitted to be included in the provisional seniority list.

In the above circumstances, the provisional seniority list of RASIs of Police of Thiruvananthapuram Range as on 01/01/2015, published vide this office order read as 1st paper above is hereby finalised and published as in the Annexure appended

herewith. The finalisation of the seniority list is subject to the disposal of OP/OA/Writ Petitions, if any, pending before the Hon'ble Courts/KAT and Govt directions.

The ASIs of Police who are included in the finalised seniority list appended, as Sl.No.124 to 133, Sl. Nos.81, 83, 111 & 121 were temporarily promoted as ASIs of Police and their inclusion in the seniority list will be subject to the approval of DPB.

The unit heads concerned in Thiruvananthapuram Range will arrange to circulate the finalised seniority list among all the concerned.
