A provisional seniority list Armourer Havildars/Head Constables in Tvpm Range as on 01/01/2017, was published vide this office order read as 1st paper above, in continuation of the finalised seniority list of Armourer Havildars/Head Constables in Thiruvananthapuram Range as on 01/01/2016, published vide this office order read as 2nd paper above.

The Unit heads concerned in Thiruvananthapuram Range were requested to circulate the same among all the concerned and to forward complaints/suggestions if any against the provisional seniority list within 10 days from the date of publication of the list.

The petition has been examined and found that, since the matter raised by the petitioner is pending with Hon'ble Kerala Administrative Tribunal/Government, this office is not in a position to review the matter. The finalised seniority list is subject to review, based on the disposal of the case pending before the Hon'ble Tribunal/Govt directions in this regard.

In the above circumstances, the Provisional Seniority list of Armourer Havildars/Head Constables of Tvpm Range as on 01/01/2017, published vide order read as 1st paper above is hereby finalized, with no changes and published herewith.

The finalisation of the seniority list is subject to the final orders with regard to the OPs/OAs/Writ Petitions, if any, pending before the Hon'ble Courts/Tribunal/Govt directions.

The unit heads concerned in Thiruvananthapuram Range will arrange to circulate the finalised seniority list among all the concerned.
