A provisional seniority list of Bugler/Drummer Personnel of Thiruvananthapuram Range as 01/01/2017 was published vide this office order read as 1st paper above, based on the directions contained in the references read as 2nd to 4th paper above.

All Unit heads concerned in Thiruvananthapuram Range were requested to circulate the same among the concerned and to forward complaints/suggestions, if any against the provisional seniority list to this office within 7 days from the date of publishing the list. Some complaints are received against the Provisional Seniority list within the stipulated period, as detailed below and all of them have been verified.

1) Sri.C.Vijayan, Drummer ASI (G) T 1387, AR, Tvpmm City

The petitioner has said that he is working as Drummer in District Armed Reserve, Thiruvananthapuram City and he has not changed his category of appointment from Drummer to Bugler & vice versa, till date. The petitioner has raised contention that he is placed in the provisional seniority list as junior to some personnel who had changed their category of appointment from Bugler to Drummer in Tvpmm City. Hence the petitioner has requested necessary steps to review his position in the seniority list.

The petition has been verified in detail and found that, since the fixation of seniority of Bugler PCs and Drummer PCs is done in the same list, based on directions from higher ups and their higher promotion posts are similar, the Bugler PCs and Drummer PCs who have joined in the units concerned by category change are placed in the seniority list by assigning eligible seniority in their entry cadre. But necessary changes as per rules are made in the criteria adopted for regularisation of appointment of the inter district/ inter unit transferees in the seniority list and as such the petitioner has been placed as SI No.15 in the finalised seniority list.

2) Sri.K.M.Abdul Sathar Khan RSI (G) Q 5628, AR, Tvpmm City

The petitioner has said that his name is omitted in the provisional seniority list and alleged that Bugler PCs who have joined as Drummer PCs by category change are wrongly given seniority w.e.f the date of joining in service as Bugler PC. Hence the petitioner has requested to place him in the seniority list by giving eligible seniority and steps to correct anomaly pointed out by him.

The petition has been examined in detail and as found eligible, the petitioner has been included in the finalised seniority as SI No.20. It is also found that the fixation of seniority of Bugler PCs and Drummer PCs is done in the same list, based on directions from higher ups and their higher promotion posts are similar. As such, the Bugler PCs and Drummer PCs who have joined in the units concerned by category change are placed in the seniority list by assigning eligible seniority in their entry cadre.

3) Sri.Sudharsanan Bugler SI (G), AR, Tvpmm City

The petitioner has raised objection that some Bugler/Drummer personnel namely Sri.Justin Raj, T 2284, Sri.Sureshkumar, T 3409, Sri.Sobhanadas, T 5620, Sri.Dalton D, T 6485, and Sri.Badarudeen, T 6860 who have entered into service after the petitioner and junior to the petitioner in AR, Tvpm City are placed in the provisional seniority list as senior to the petitioner. Hence the petitioner has requested to allow him eligible seniority in the finalised senioriy list.

The petition has been examined in detail and the personnel alleged in the petition along with the petitioner have been given appropriate places in the finalised seniority list, based on merits.

4) Sri.Joshilal, BHC T 5361, AR, Tvpm City

The petitioner has said that he was joined in service on 01/03/2006 and alleged that he has to be placed in the seniority list above one Sri.Syamkumar, Bugler HC, who had joined in KAP III Battalion, Adoor on 14/03/2006. Hence the petitioner has requested to take rectify the error in this regard.

The petition has been examined in detail and found that the petitioner was received to Tvpm Range on Inter district transfer from KAP II Battalion, Palakkad. As such the petitioner has been assigned appropriate place in the seniority list, based on the date of joining duty in Tvpm City. Hence the petition is denied on merits.

In the above circumstances, the Provisional Seniority list of Bugler/Drummer Personnel of Thiruvananthapuram Range as on 01/01/2017, published vide this office order read as 1st paper above is hereby finalised with the changes as necessary and published as in the Annexure appended herewith. The finalisation of the seniority list is subject to the disposal of OP/OA/Writ Petitions, if any, pending before the Hon'ble Courts/KAT and Govt directions.

The unit heads concerned in Thiruvananthapuram Range will arrange to circulate the finalised seniority list among all the concerned forthwith.
