**Order No : A5-3578/2017/TR Dated. 20-01-2018**

A finalized seniority list of Bugler/Drummer Personnel of Thiruvananthapuram Range as 01/01/2017 was published vide this office order read as 1 st paper above, based on the directions contained in the references read as 4th to 6th paper above. The ADGP, Armed Police Battalion, vide reference read as 3rd paper above has informed that the seniority lists, published by the Ranges are not in order. It has been directed to prepare the seniority list in a prescribed format and forward the seniority list of Buglers/Drummers as per their date of appointment. It is also directed that, in case of the incumbents who were on category changes from other categories, their seniority may be assigned as per the date of joining in the present post.

As such, a provisional seniority list of Bugler/Drummer Personnel of Tvpm Range as 01/01/2017, was published vide this office order read as 1st paper above, by modifying the finalised seniority list of Buglers/Drummers as on 01/01/2017, published vide this office order read as 2nd paper above, based on the further directions received vide reference read as 3rd paper above.

The Unit heads concerned in Thiruvananthapuram Range were requested to circulate the provisional modified seniority list among all the concerned and to forward complaints/suggestions, if any received against the provisional seniority list to this office within 7 days from the date of publishing the list.

**Sri.Sudharsanan L, Bugler GSI, AR, Tvpm City** has raised objection that the petitioner is placed in the provisional seniority list as SI No.9 and Sri.Suresh Kumar T 3409, who is entered into service as junior to the petitioner in AR, Tvpm City is placed as senior to him as SI No.6 in the provisional seniority list. Hence the petitioner has requested to restore his seniority in the category.

The petition has been examined in detail and found that Sri.Sureshkumar Bugler T 3409, AR, Tvpm City has entered into service as Bugler PC in Special Armed Police, Tvpm vide BO No.126/86/S dated 19.04.1986 and transferred to Police Training College, Tvpm by keeping the lien in SAP. While the incumbent was working at PTC, the post was shifted to KEPA, Thrissur and he was repatriated to his parent unit, SAP. Then he was transferred to KAP 5th Battalion, for want of vacancy in SAP to accommodate him. Later he was transferred and posted to AR, Tvpm City as per DGO No.198/2006 dated 15/02/2006, as a vacancy in the category of Bugler PC was arised in Tvpm district. As the incumbent was transferred in & out of the units without the willingness and request of the incumbent, he has been assigned the eligible seniority in the category of Bugler PC in the seniority list of Buglers/Drummers of Tvpm Range as on 01/01/2017, published vide order read as 1st paper above. As such the petition has found no merits and hence denied.

In the above circumstances, the Provisional Modified Seniority list of Bugler/Drummer Personnel of Thiruvananthapuram Range as on 01/01/2017, published
