(1) A Statewide Combined Seniority list of Sub Inspector of Police (GE Branch) for the period from 01.01.2007 to 31.03.2010 was published and finalized vide PHQ Order cited 1st.

As per the references cited 2nd read above, District Police Chief Pathanamthitta has reported that the name of Sri.T.K.Vinodkrishnan, SI of Police, DCB, Pathanamthitta was excluded in the Finalized Seniority List of SIs for the period from 01.01.2007 to 31.03.2010.

On further verification on the basis of the report, it is found that the name of Sri.T.K.Vinod krishnan, SI of Police, DCB, Pathanamthitta was included in the provisional Seniority List of SIs(GE) for the year 2009 as SL No. 918 published vide reference cited 2nd. But, his name was excluded in the Finalized Seniority List by oversight. Sri.T.K.Vinod krishnan, SI of Police is eligible for inclusion in the Seniority List reckoning the date of advice and is to be ranked between Sri. Gireesh.N, SI of Police & Sri. Renjith Kumar.J.R, SI of Police.

Therefore, the name of Sri. T.K.Vinodkrishnan, SI of Police is included in the Seniority List of SIs (GE) for the period from 01.01.2017 to 31.03.2010 as furnished below.

But, no representation was submitted by the petitioner before finalizing the Provisional Seniority List. However, necessary corrections have been made on the basis of the report received from the Dist.Police Chief, EKM Rural vide reference cited 7th.
