Vide the read second, based on the Government direction, State Police Chief, Kerala has directed to revise the Range - wise Seniority List of Sub-Inspectors of Police (GE) for the period from 1996 to 2006 in order to maintain 1:1 ratio between direct recruited Sub-Inspectors of Police and Promotees.

As such, Range Seniority List of Sub-Inspectors of Police (GE) published from this Range vide the read fourth is to be revised.

Under the circumstances, Range wise seniority list of Sub-Inspectors of Police (GE-Promotee) published for the period from 1996 (as on 01.01.1997) to 2006 (as on 01.01.2007) is revised and published hereby regularizing 50% of the sanctioned strength to promotee SIs (GE) every year. 38 posts for the year 1996, 39 posts for 1997, 44 posts for 1998 and 44 posts for 1999 which are equivalent to number of post of special units that was reported to KPSC for direct recruitment has been reckoned for regularization of promotee SIs in the range to maintain the ratio of 1:1 in the years from 1996 to 1999 as directed vide PHQ letter E2/186119 dated 12/04/2018. The forty one (41) posts of special units allotted for regularization vide PHQ No. E2/91359/08 dated 30.01.2009 are also taken into account for regularization from 2000 onwards. The revised year-wise seniority list for the years from 1996 to 2006 is appended herewith. This office order read fourth stand modified to this extend.

The District Police Chiefs/Superintendents of Police and the concerned officers will circulate the list among the concerned under proper acknowledgement. Omissions, objections, suggestions, errors etc. if any received against the year-wise seniority lists should reach this office with specific remarks within 10 days positively. The belated representations will not be entertained and the list will be finalized accordingly.
