The finalized seniority list of UD Clerks in Police Department as on 22.2.2003 containing names of 646 incumbents has been published as per the letter read as (1) above.

In compliance with the Judgment of the Hon'ble High Court of Kerala read as (2) and (3) above, the revised Finalized Seniority lists of Test qualified LD Clerks in Police Department as on 9.9.1994 and up to 28.10.2010 (32 lists) have been published as per the order read as (4) above. In view of the Seniority list read as (4) above, the seniority position of Sl. No.586 to 646 in the list read as (1) above requires modification.

Based on the finalized seniority list of Test qualified LD Clerks read as (4) above, the provisional seniority list of Senior Clerks (UDCs) in Police Department as on 25.3.2011 is published herewith for information of all concerned. All are requested to submit objections, if any, against the list within 10 days from the date of publication of the list.

The Unit Officers concerned are requested to inform the details among the Ministerial Staff and forward objections, if any, received with remarks to reach here within the stipulated time.

If no objection is received within the time limit prescribed, the list will be finalized on the presumption that there is no objection against the list.

The list will be subject to the disposal of the OA No.288/2012 filed before the Hon'ble Kerala Administrative Tribunal.
