The Provisional Seniority list of Inspectors of Police(Telecommunication) as on 01.01.2017, prepared was circulated among the officers concerned inviting objections if any. The representations received vide reference cited 2nd, are detailed below:

1.Sri.Sihabudeen.A,IP(Tele), Tele Sub Unit Kollam

In the representation, he has pointed out that his name in the provisional seniority list is entered as Shihabudeen A. instead of Sihabudeen A. On verifying the relevant records, it is found that his claim is genuine. Necessary correction has been made in the finalized seniority list.

2. Sri.Raveendran Nair.R, IP(Tele),Tele Sub Unit TVPM City

In the representation he has pointed out that his date of birth in the provisional seniority list is noted as 05.03.1963 instead of 12-03-1963. On verifying the service records, it is found that his correct date of birth is 12.03.1963. Necessary correction has been made in the finalized seniority list.

3.Sri.Santhosh Kumar.C, IP(Tele), Tele Sub Unit Kozhikode Rural

In the representation he has pointed out that in the provisional seniority list, the dates of promotion to the cadre of IP(Tele) are not mentioned for Sl.No.28 & 29 and the date of promotion mentioned for Sl.No.30 is 01.02.2013 instead of 11-02-2013.Necessary corrections are made in the finalized seniority list in this regard.

4.Sri.Sunny.V.D, IP(Tele),Tele Sub Unit,Thrissur

In the representation, he has pointed out that in the provisional seniority list his date of promotion to cadre of IP(Tele) is 01.02.2013 instead of 11.02.2013. Necessary correction is made in the finalized seniority list in this regard.

5. Sri.Shanmugh .A.M, IP(Tele),Tele Sub Unit TVPM RL

The applicant submitted that his petition regarding seniority is under consideration before the Hon'ble KAT and the Government. Hence his petition for claiming the seniority is still existing against the provisional seniority of IP(Tele) as on 01.01.2017. The present provisional seniority list of IP(Tele) is, as on 01.01.2017. But the applicant was promoted to the cadre of IP(Tele) on 09.06.2017 only vide DGO No. 1384/17/PHQ dated 09.06.2017. As such the incumbent is not eligible to be included in the above list. Hence his representation can not be considered.

In the above circumstances, the provisional seniority list of IP(Tele) as on 01.01.2017 vide reference first cited, is finalized by incorporating the above inclusion and the finalized seniority list of Inspector of Police(Telecommunications) as on 01.01.2017 is published herewith.

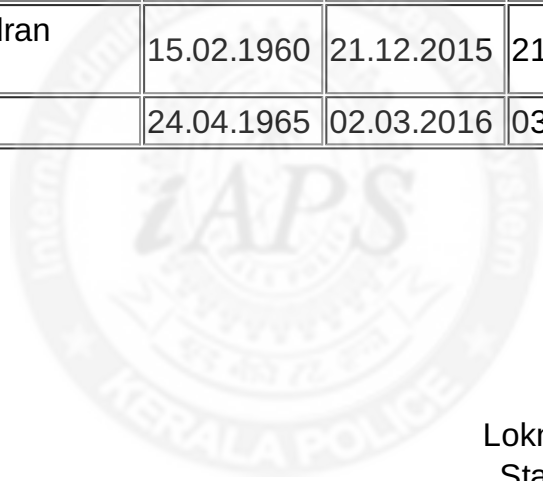
