NOTIFICATION

With a view to usher in a concept of '**Digital Traffic Checking and Enforcement**', Kerala Police desires to implement an Integrated Highway Traffic & E-challan System in the State for the payment of fines. It is envisaged to involve the deployment of a Digital Challan Instrument along with a mobile App, so as to digitally detect traffic violations, which will be connected to a Centralised Control Room. It is from this Control room that the challans will be issued to the defaulters for payment of fines. This system also involves the digitization of fine payment by providing traffic offenders an option to remit fines digitally on the spot by installing the gadget/system in all patrolling vehicles. The vision is to fully automate the enforcement of fines through E-Challan system throughout Kerala by deploying hand held computers enabled devices with built-in printers in all Police Districts of Kerala.

02. If a traffic offence is detected digitally or by the Police Patrolling team, and if the offender opts to pay the fine digitally, the fine amount will be drawn from his account and the same will be credited to an account (to be opened) of the State Police Chief kept in the Bank which provide the gadget/system to Police Department. When the payment is done, a receipt will be generated through the machine. The machines should be capable of obtaining details of the license holder or the registered owner of the vehicle using license number or the registration number. There must be provisions to store the details of such challans generated by each of the patrolling teams in a centralised system.

03. To realize the vision, Kerala Police has decided to invite proposals from Scheduled/ Commercial Banks for running a pilot project in Thiruvananthapuram City for 1 Month by providing user friendly and Mobile Digital payment solutions including equipments, software, maintenance etc. Interested Banks are requested to furnish Detailed Project Report to the Inspector General of Police, Traffic & Road Safety Management, Police Training College Campus, Thiruvananthapuram by **25th July, 2018.**
