Sir,

Kindly refer this Office DO letter of even No. dated 7/3/2018 calling for nominations for MCTP Phase.IV scheduled to commence on 14/5/2018.

2. MHA vide letter No. F.No.23011/56/2017-PT dated 22/3/2018 conveyed the approval for Foreign Component of MCTP Phase.IV programme.

3. Hence, the Phase.IV programme is scheduled to commence at the Academy for Three Weeks from 14.5.2018 to 01.06.2018 and followed by One week Foreign Component to be held in UK wef. 04.06.2018 to 08.06.2018 (5 days excluding travel time).

4. **The following guidelines may please be brought to the notice of nominated officers:-**



- a. Immediately on conclusion of the due date for receipt of nominations, i.e. 6/4/2018, the Academy will finalize the select list and intimate the names of selected Officers to concerned DsGP of States and CPOs by 9/4/2018. The political clearance for travelling to UK in respect of selected participants will also be obtained from MEA and will be communicated to all the participants.
  - b. The detailed joining instructions will be issued alongwith the select list.
  - c. The selected Officers before reporting to the Academy are required to obtain their Official Passports & Visa to UK.
  - d. **To and Fro** Air tickets for their journey to London will be booked by the Academy in Air India economy class. All the participants regardless of their entitlement will be travelling in economy class group bookings.

- e. Single room accommodation at UK during the one week of Foreign component of Phase-IV MCTP for 6 nights ( i.e. from 3/6/2018 to 8/6/2018) will be arranged and families will not be permitted to accompany.
- f. During their stay at UK as part of study visit, families shall not be allowed. The participants shall not be permitted to take their spouse/family to UK during such period of the foreign component of Phase.IV MCTP.

**As the Foreign component involves lot of preparatory arrangements, all CCAs are requested to forward nominations of eligible IPS Officers either by Fax No. 040-24015179 or by e-mail to mctp4@svpnpa.gov.in so as to reach the Academy by 6/4/2018 (Repeat 6/4/2018) without fail. Post may please be avoided to prevent delay. No nomination after due date will be accepted by the Academy under any circumstances. While submitting nominations, please intimate nominated Officer's present address / E-mail.ID/ Telephone No.of Office/Residence/Fax No./ Mobile No. /Date of Birth/ Native State/Educational Qualifications, Pay Particulars, posts Held, Extracurricular activities, interested field etc,. The names may be spelt exactly as per their passport.**
