Sub : Provisional retirement list of Executive/Ministerial/PTS/CFs during the year 2018- list published – orders issued.

The list of Police Personnel/Police Officers/Ministerial Staff/Camp Followers and P T Sweepers of this unit, who are due to retire from service on superannuation during the year 2018 with effect from the dates noted against each is hereby published.They will be relieved on the date of superannuation after collecting back all the Government properties which are to be surrendered before their retirement from service and they would not be retained in service beyond that date on any account.

Liabilities if any, outstanding against the retiring officers should be assessed and reported to this office sufficiently early to effect the recovery from their last pay. The SHOs, Officers in SDPOs and Special Units, Dy Commandant, Dist.Headquarters (Reserve) Alappuzha and Manager DPO are hereby directed to verify the date of birth of all Police personnel working under them with reference to their Small Service Books etc., and report immediately to this office whether the name of any person has been excluded from the list furnished .If any error is noticed in the list after verification of Small Service Books/MH Sheet, etc the fact should be informed to this office forthwith. All officers will forward a compliance report in the matter within a week without fail.

It may also be noticed that, if anybody happens to be retained in service and draw/receive pay and allowances after the age of 56 years i.e., after the date of retirement on superannuation (except PTS) the concerned Officer will be held personally responsible for the lapses. Content of this ADO will be brought to the notice of each personnel whose name is included in the list and obtain their dated acknowledgement on the list against their name and return to this office duly certified to the effect that " The list has been circulated among all concerned working in this Unit/ Police Station and obtained their dated signature and also ensured that nobody is excluded in the list". If noticed that any one is excluded in the list, the name, rank, designation/date of birth,date of retirement, etc of such employees may be furnished to this office immediately for inclusion in the list.

The Concerned Officers should forward the following reports to this office within 6 days from the date of retirement of the employees concerned.

3. Exact designation and Grade Designation if differs, in this ADO.

The Officers Concerned will direct the personnel included in the list, to submit Pension Book and connected documents before 6 months from date of retirement so as to process the same sufficiently early. The personnel can submit their request to discontinue their subscription towards GPF before one year from the date of retirement.

Leave Sections DPO will take necessary action to sanction Terminal surrender of earned leave immediately after retirement without waiting for application from the individual.

As per GO(P) No 285/90/Fin dated 28.4.90, the subscription to FBS are given option to remit the subscription in lump for last six months prior to retirement for speedy settlement of the claim . F2 Section, DPO will ensure that the FBS closure amount is paid without any delay. The same procedure shall be adopted in the case of GIS also by the concerned sections.

In the case of GIS, Applications in form No.3 shall be obtained well in advance and the entries in the pass book made up to date. Proposal for final payment should be sent to the Director of Insurance without delay.

Lump sum grant from KPW&A fund to the retired personnel as admissible in GO(MS) 1196/81/Home dated 3.12.81, the same shall be calculated well in advance after obtaining the details of recovery of subscription from former units if required. The concerned section will take early action in the matter in this office.

If any Men/Officers who are due to retire within 31-12-2018 received on transfer from other units after issuing this order, the name of such personnel with their date of birth will be intimated to this office as and when they reported for duty in Police Stations/Offices.
