All officers are directed to verify the date of birth of all employees working under their with reference to their small Service book and correction/omission if any should be reported in time.

If any officer is received on transfer from any other district or separate unit subsequently is found due for retirement on Superannuation during 31st January 2017 to 31st December 2017, after the issue of this DO, their name, rank, date of birth etc.should be reported to this office by officers concerned under whom he/she is working without fail for verification and incorporation of their names.

All officers should ensure that no person are in service beyond their retirement date and that no one is excluded from the list. if anybody happens to draw and receive pay and allowances after their retirement, the concerned Officers/SHOs will be held personally responsible for the lapses. A copy of the order should be got noted by the respective person under proper acknowledgement and they may be instructed to submit their pension documents as mentioned below to this office well in advance at least six months before their date of retirement. The retiring person will fill up the pension book page No.7,8,29,33,35,37,39,43,47 of the pension book.

- 1) Pension book (2 nos)
- 2) 3 copies of identification particulars, specimen signature, left hand thumb and finger print duly attested by the CIs concerned.
- 3) Five copies of joint photograph of the individual with their wife/ husband of those photograph should be pasted in the pension book and three of them should be attested by the CIs concerned.Gazetted officers should send their pension book and connected



documents to this office for forwarding to PHQ, well in advance. The concerned officers should forward the following reports to this office within six days after the date of retirement of the employees concerned.

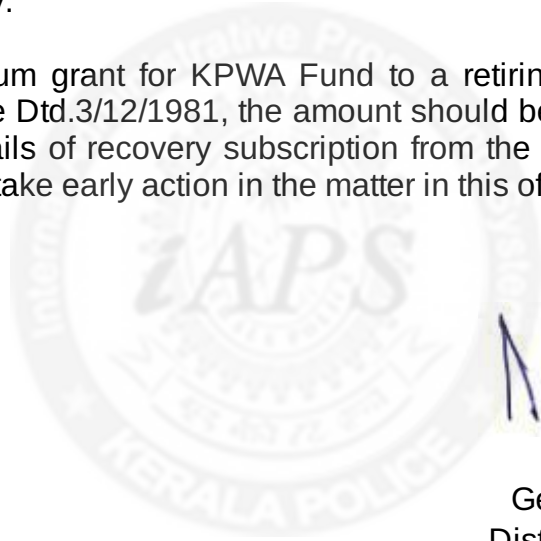
- 1) Liability/ Non liability report
- 2) LR pending details.

On his/ her option the subscriber can be stop the subscription to GPF account early to retirement and apply for closure of accounts in advance. This chance can be utilized by the retiring personnel in order to receive his/her GPF closure amount without delay. Terminal surrender of earned leave can be sanctioned to a retiring person immediately after the retirement without waiting for application from the individual. The leave section will ensure early action will be taken in this regard to the settlement of earned leave accounts.

As per the GO(P) No.285/90 Fin dtd.28/4/90, the subscriber to FBS are given option to remit the subscription in lump for last six months prior to retirement for speedy settlement of the claim. The retiring person can utilize the chances in time, he/she can submit application to this office well in advance before six months for the recovery of FBS subscription in lump.

As in the case of FBS, option for recovery in lump of six months premium to GIS will also be made. But the financial settlement of the scheme will be taken up only after the date of retirement, in order to ensure contained insurance coverage on envisaged in the scheme. Application in Form No 3 should be obtained well in advance and the entries in the pass book made up to date. Proposal for final payment should be sent to the director of insurance without delay.

Payment of lumpsum grant for KPWA Fund to a retiring person as admissible on GO(MS) 1196/81 Home Dtd.3/12/1981, the amount should be calculated well in advance after obtaining the details of recovery subscription from the former units if required. The concerned section will take early action in the matter in this office.
