Suresh G Krishnan is granted notional promotion as UDC wef 30/3/2004, ie. date of promotion of his immediate junior Sri. Manoj P B and placed as Sl. No. 137(a) in the finalized Seniority List of UDCs as on 25/3/2011 published vide proceedings 2nd cited. Aggrieved by this, Smt. Tessymol E B submitted representation to Govt. for protecting her seniority by placing her above the junior Suresh G Krishnan. Govt. have now issued clear instruction vide reference 4th cited for protecting her seniority by placing above Sri. Suresh G Krishnan.

In the above circumstances, Smt. Tessymol E B is granted notional promotion as UDC wef 30/3/2004, ie. date of notional promotion of her immediate junior, Sri. Suresh G Krishnan and placed her as Sl. No. 137(a) in the finalized seniority list of Senior Clerks (Upper Division Clerks) as on 25/3/2011 published vide proceedings 2nd cited. Accordingly, the position of Sri. Suresh G Krishnan is re-assigned as Sl. No. 137(b).

Smt. Tessymol E B is also granted notional promotion as Head Clerk wef 18/9/2014 and as Junior Superintendent wef 15/6/2016 ie. the date of notional promotion of Sri. Suresh G Krishnan.
