The range wise select list of senior ARHCs (Closed AR) fit for promotion as ARASIs (Closed AR) for the years 2012 to 2016 (for the vacancies from 2013 to 2017) is got approved from PHQ vide reference 1st cited and published from this office vide reference 2nd cited.

In pursuance of GO cited 3rd and PHQ circular cited 4th, it is stated that all transfers and promotions in the AR and GE cadres brought into effect from 01.04.2010 FN will be deemed to have been made subject to the conditions imposed in the Local-AR integration. More all persons who continue in the AR Cadre without opting KCP will get promotion to the higher rank, subject to satisfactory records of service and evaluation by Departmental Promotion Board as the case may be, on the date calculated as their Expected Date of Promotion (EDP) as on 01.04.10 FN. The date may be calculated on the basis of existing vacancy, but any post on higher rank vacated by those of the AR cadre who opt for serving in the KCP shall not be reckoned as vacancies in closed AR for promotion. As such there is 2 AR HCs in Tvpm Range opted for KCP on or after 01.04.2010. Hence 2 posts of ARHCs along with the date of occurrence of vacancy is considered to be shifted to KCP cadre.

On calculation of EDP, the above mentioned ARHCs who opted KCP have been notionally assigned seniority in the present Range wise seniority list and the details regarding their EDP is furnished below.
