Akshat.V.P, Havildar 12211,RRRF, has submitted representation that the provisional seniority list didnot contain the Date of Declaration of Probation in the cadre of PC.The petition has been examined with reference to connected records and necessary entry has been made accordingly in the finalized list.

7.Sri.Amal Babu.M.S, Havildar 12210, SAP has submitted representation to reckon the seniority in respect of Sri.Amal Babu.M.S, Havildar 12210 and Sri.Anandu Jeevan.S.R ,Havildar 12208 in the provisional seniority list as per rule the same has been examined and find that the personnel are placed in the provisional seniority list as SI.No.187 and SI.No.186 respectively.On verifying the connected records Sri.Amal Babu.M.S, Havildar 12210 and Sri.Anandu Jeevan.S.R ,Havildar 12208 passed the havildar promotion test vide BO NO.523/2018/S Dated.02.11.2018.Accordingly they were promoted as Havildar vide BO No.528/2018/S Dated.05.11.2018 and assigned seniority w.e.f the date of order of promotion as per Rule 27(a) of KS & SSRs.Hence his request deserves no merit.




