In compliance of the Common Orders of the Hon. Kerala Administrative Tribunal in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016, a provisional seniority list of Armed Police Sub Inspectors who got inclusion in the seniority list as per Order No. L1-252/2005 dated 3.01.2005 as on 31.12.1999 but remained in service as Armed Police Sub Inspectors mentioning as "cannot be regularized for want of vacancies" and incorporating the directly recruited APASIs under Sports merit, later promoted as APSIs and APSIs recruited through KPSC published and communicated as per Proceedings read as 6th paper above, allowing 15 days time to submit objections/suggestions in the matter. All the representations received have been verified with relevant records and rules and individual replies on the same are furnished below:-

1. S. Sathyaseelan, Armed Police Inspector, KAP 3.

He represented that his rank as APSI to be restored below Serial No. 155 Sri. B. Mohanan, as was done as per Order No. A1-8306/2017/APB dated 20.02.2018 followed by the Order of KAT in OA No. 1752/2012 etc. In this regard it was stated that his name had been included in the seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. High Court of Kerala), as Serial No.359, ie in between Sri.T K Geneshan and Sri. Suresh S, and as per the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019, the seniority list of Armed Police Sub Inspectors published vide PHQ order

No.L1/252/2005 Dated.03.01.2005 has been restored retaining rank and seniority. Hence his request deserves no merit.

2. S. Suresh, Armed Police Inspector, KAP 1

He represented that his rank as APSI has to be restored below Serial No. 155 Sri. B. Mohanan, as was done as per Order No. A1-8306/2017/APB dated 20.02.2018 followed by the Order of KAT in OA No. 1752/2012 etc. In this regard it stated that his name had been included in the seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. High Court of Kerala), as Serial No.360, ie in between Sri. Sathyaseelan and Sri. Unnikrishnan P, and as per the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019, the seniority list of Armed Police Sub Inspectors published vide PHQ order No.L1/252/2005 Dated.03.01.2005 has been restored retaining rank and seniority. Hence his request deserves no merit.

3. C. Chandrakumar API (Rtd)

He represents to retain his seniority as APSI which remains regularized with effect from 31.01.1993 as it is a settled seniority. In this regard it is stated that his name had been included in the seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. 331 as APSIs from Serial No.331 to 357 were junior to him and to restore his seniority as per Order No. A1-8306/2017/APB dated 20.02.2018 followed by the Order of KAT in OA No. 1752/2012 etc. In this regard it is stated that his name had been included in the seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. High Court of Kerala), as Serial No.358, in between Udayan D. and Sathyaseelan, and as per the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019, the seniority list of Armed Police Sub Inspectors published vide PHQ order No.L1/252/2005 Dated.03.01.2005 has been restored retaining rank and seniority. 6. P. Unnikrishnan, API, KAP 1 Bn

He had represented that his rank as APSI to be restored above Serial No. 331 as APSIs from Serial No.331 to 357 were junior to him and to restore his seniority as per Order No. A1-8306/2017/APB dated 20.02.2018 followed by the Order of KAT in OA No. 1752/2012 etc. In this regard it is stated that his name had been included in the seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. High Court of Kerala), as Serial No.361, in between Suresh S, and Mohanan Nair P.K, and as per the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019, the seniority list of Armed Police Sub Inspectors published vide PHQ order No.L1/252/2005 Dated.03.01.2005 has been restored retaining rank and seniority. In this regard, it is stated that neither Special Rules nor General Rules permit to assign seniority of personnel from the date of promotion on out of turn basis. The seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. High Court of Kerala) has been restored as per the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019, retaining rank and seniority and as such his request for inclusion in the seniority list of APSIs as on 12.07.2013 deserves no merit.

10. Sri. K. Mohan Kumar, API, RRRF

He had represented that his rank as APSI to be restored as per Order No. A1-8306/2017/APB dated 20.02.2018 followed by the Order of KAT in OA No. 1752/2012 etc. In this regard it is stated that his name had not been included in the seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. This seniority list was a follow up action taken in continuation of the Combined Havildar seniority List of DIG APBn published as per Order No. A1-3188/2003 dated 23.06.2004. It is further stated that neither Special Rules nor General Rules permit to assign seniority of personnel from the date of promotion on out of turn basis, as such his request for inclusion the seniority list of APSIs as on 12.07.2013 deserves no merit.

12. Sri. Manoj Sebastian, API, KAP 5

In this regard it is stated that the seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. High Court of Kerala), has been restored as per the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019, retaining rank and seniority. High Court of Kerala) has been restored as per the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019, retaining rank and seniority. In this regard it is stated that the PHQ Proceedings No. A7-99387/15/PHQ dated 17.11.2016 stands quashed as per the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019. In the above circumstances his request deserves no merit.

17. Sri. C. Sreekumar, API (Rtd)

He represented that his rank as APSI to be restored based on the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019. In this regard it is stated that his name remains included as serial number 317 in the seniority list of Armed Police Sub Inspectors published vide PHQ order No. L1/252/2005 Dated 03.01.2005(which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. High Court of Kerala) and hence he deserves seniority as APSI accordingly.

18. Ajith Kumar CP, API, MSP

He represents that the number of vacancies identified as per Order No. A7-99387/15/PHQ dated 17.11.2016 and the provisional seniority list of APSIs as on 12.07.2013 differs. In this regard it is stated that the PHQ Proceedings No. A7-99387/15/PHQ dated 17.11.2016 stands quashed as per the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019.

19. Sri. Basheer KA, API, IR Bn

He had represented that his rank as APSI to be restored as per Order No. A1-8306/2017/APB dated 20.02.2018 followed by the Order of KAT in OA No. 1752/2012 etc. In this regard it is stated that his name had not been included

In this regard it is stated that the PHQ Proceedings No. A7-99387/15/PHQ dated 17.11.2016 stands quashed as per the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019.

31. Sri. C. Asokan, AC, KAP 4

He represents that his promotion as APSI wef 1.06.1990 was upheld by the judgment in WP(C) No. 15463/2010-G and ultimately he is holding the post of Assistant Commandant with date of regularization 1.06.2003 as per the seniority list of ACs published by Government as per Order No. 33028/A1/11/Home Dated 23.08.2011 and the present revision of seniority list of APSIs as on 12.07.2013 is discriminatory, arbitral and hence illegal and to be reviewed.

In this regard it is stated that he was one among the party respondents in the in OA (Ekm) No. 2915/2017 and the Hon. KAT delivered a Common Order on the above OA. In allowing OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018, the Hon. KAT issued three Orders, after disposing OA No.1168/2016 and dismissing OA No. 1728 of 2018 filed by him and others. As per the same Annexure A15, A15 (a), A20, A20 (a), A23, A25, A25 (a) in OA (Ekm) No. 2915/2017 & OA No. 242/2018 to the extent to which they adversely affect the applicants and granted position and seniority to the seniors to the party respondents in (Applicants in OA No. 1728/ of 2018) in the cadre of APSI,



and API are quashed and similarly Annexure A24, A26, and A28 produced in OA (Ekm) No. 817/2018 to the extent they are adverse to the Applicants in the said OA and granted seniority to party respondents are also quashed. Moreover, his name remains included as Serial No. 247 in the seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. High Court of Kerala) which remains restored by retaining rank and seniority by the above Hon. KAT Orders. Hence his request deserves no merit.

32. Sri. T.P Syamsundar, AC, KAP 2

He represents that his promotion as APSI wef 1.06.1990 was upheld by the judgment in WP(C) No. 15463/2010 and ultimately he is holding the post of Assistant Commandant with date of regularization 01.10.2002 as per the seniority list of ACs published by Government as per Order No. 33028/A1/11/Home Dated 23.08.2011 and the present revision of seniority list of APSIs as on 12.07.2013 is discriminatory, arbitral and hence illegal and to be reviewed.

In this regard it is stated that he was one among the party respondents in the in OA (Ekm) No. 2915/2017 and the Hon. KAT delivered a Common Order on the above OA. In allowing OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018, the Hon. KAT issued three Orders, after disposing OA No.1168/2016 and dismissing OA No. 1728 of 2018 filed by him and others. As per the same Annexure A15, A15 (a), A20, A20 (a), A23, A25, A25 (a) in OA (Ekm) No. 2915/2017 & OA No. 242/2018 to the extent to which they adversely affect the Applicants and granted position and seniority to the seniors to the party respondents in (Applicants in OA No. 1728/ of 2018) in the cadre of APSI, and API are quashed and similarly Annexure A24, A26, and A28 produced in OA (Ekm) No. 817/2018 to the extent they are adverse to the Applicants in the said OA and granted seniority to party respondents are also quashed. Moreover, his name remains included as Serial No. 248 in the seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. High Court of Kerala) which remains restored by retaining rank and seniority by the above Hon. KAT Orders. Hence his request deserves no merit.

33. Sri. C.M. Sudheer Kumar, AC, RRRF

He represents that he was initially appointed as APASI 20.04.1988 remains regularized as per GO(Ms) No. 30/94/Home dt. 3.03.1994 and certain juniors who remains promoted after initial appointment as APASI crept in the provisional seniority list of APSIs and requested to provide right place in the seniority list considering his initial appointment as APSI. In this regard it is stated that his name had been included in the seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. In this regard it is stated that the seniority list of APSIs published vide PHQ Order No.L1.252/2005 Dated.03.01.2005 (which was upheld as per Common Judgment in WA No. 462/02 dt. 20.06.2005 of the Hon. High Court of Kerala), and as per the Hon. KAT Orders in OA (Ekm) No. 2915/2017, OA No. 242/2018 & OA (Ekm) No. 817/2018 and in OA No.1168/2016 dated. 20.05.2019, the seniority list of Armed Police Sub Inspectors published vide PHQ order No.L1/252/2005 Dated.03.01.2005 has been restored retaining rank and seniority. This seniority list was a follow up action taken in continuation of the Combined Havildar seniority List of DIG APBn published as per Order No. A1-3188/2003 dated 23.06.2004. Hence his request deserves no merit.

35. Moideen Hussain, Armed Police Inspector, MSP (KLA on deputation)



Simultaneously the APSIs under recruitment by KPSC are also given suitable placing based on the date of effective within the quota stipulated in the above Special Rule. In the above circumstances his request deserves no merit

Sri.C K Raju, now Armed Police Inspector, was not included in the Provisional Seniority List of Armed Police Sub Inspectors issued vide reference 6th cited due to omission. He was initially appointed as Armed Police Assistant Sub Inspector under Special Recruitment Scheme vide KPSC advice letter No.SRI(3)2091/1990/SW Dated.02.01.1996. He was eligible for regularization as APSI with effect from 12.07.2013. Hence he is included in between Sri.Murukadasan Nair and Sri.Ayyappan K K.

As I am authorized as per GO (Ms) No. 43/2019/Home Dated 26.03.2019 to



prepare the seniority lists of AP Battalion from the category of Havildar to Deputy Commandant, the provisional seniority list of APSIs for the period from 01.01.2000 to 12.07.2013 issued vide order 6th cited is hereby finalized and appended as annexure to this order. This order is subject to the disposal of cases pending in the Hon KAT/High Court of Kerala.
