As per the direction contained in letter 1st, Seniority List of KAP II Battalion Havildars for the period from 01.01.1992 to 31.12.2011 was prepared and finalized in this Battalion vide this office order dated.18.05.2018 cited 2nd.

An OA (EKM) 1304/18 was filed before the Hon'ble Kerala Administrative Tribunal against the seniority lists published vide order cited 2nd and all further proceedings in this regard was stayed as per interim Order Dated. 29.06.2018 in the OA (EKM) 1304/18.

Meanwhile, based on the instructions in GO (MS) No.147/2018/Home Dated.19.09.2018, APBn had directed to prepare and to finalize the Havildar seniority for the period from 01.01.1992 to 31.12.2011 vide letter cited 4th. Accordingly, seniority of KAP II Battalion havildars again was prepared and finalized in this unit on 23.10.2018 vide Order dated cited 5th.

Contempt petition have been filed before the Hon'ble Kerala Administrative Tribunal and Hon'ble High Court of Kerala against the seniority lists published vide reference cited 5th and the State Wide combined provisional Seniority list of APBn havildars published vide APBn Order No : A8-16023/2018/APB Dated. 05-11-2018 respectively.

In the above circumstances, as per the direction contained in the APBn letter cited 8th, the finalized seniority list of KAP II Battalion Havildars for the period from 01.01.1992 to 31.12.2011 mentioned therein , issued vide this office order dated. 18.05.2018 and 23.10.2018, cited 2nd and 5th are hereby cancelled with immediate effect.
