In compliance with the direction of the Hon'ble Supreme Court in WP(C)No.754/2016 filed by Tehseen S Poonawalla Vs Union of India and others, the District Police Chiefs were designated as the Nodal Officers in their respective districts who shall be assisted by one DySP rank officer of the districts nominated by the Superintendent of Police for taking measures to prevent incidents of mob violence and lynching or who are involved in spreading hate speeches, provocative statements and fake news vide PHQ Circular No.24/2018 dated 05-09-2018.

The Hon'ble Supreme Court in its order dated 11/08/2023 in WP(C)No.943/2021 filed by Ashwini Kumar Upadhyay Vs Union of India and others has directed the applicant /petitioner to sent copies of the material available with them, including electronic material to the nodal officers appointed in compliance with the decision rendered by the Hon'ble Supreme Court in Tehseen S Poonawalla Vs Union of India and others.

Since it has become imperative to inform the Hon'ble Apex Court about the status of the appointment of Nodal Officers for taking measures to prevent incidents of spreading hate speeches in the wake of the order pronounced by the Hon'ble Supreme Court on 25/08/2023 in WP(C)No.943/2021 filed by Ashwini Kumar





Upadhyay Vs Union of India and others, the District Police Chiefs who were designated as Nodal Officers of the Districts in Tehseen S Poonawalla Vs Union of India and others case, as per PHQ Circular No.24/2018 dated 05-09-2018, are also designated as the Nodal Officers in the Districts for taking measures to prevent incidents of spreading hate speeches, as desired by the Hon'ble Apex Court.
