O1. Sealed quotations are invited for entering into a **Comprehensive Annual Maintenance Contract (AMC)** for **3 Nos. of printers** installed at the **Drone Forensic Lab & Research Centre**, a unit under the Kerala Police Cyber Division, for a period of **three (3) years**.

02. SCOPE OF WORK

The AMC covers the following 3 printers:

- Epson L3150 (1 No.)
- HP LaserJet M208dw (1 No.)
- Canon MF645CX (1 No.)
- 1. The scope shall be comprehensive: preventive and breakdown maintenance, routine servicing, cleaning of printer components, replacement of consumables (including ink/toner cartridges), and repair or replacement of faulty parts to ensure optimal performance and uninterrupted operation of all printers.
- 2. Preventive maintenance once every 3 months (quarterly)
- 3. Response time for breakdown: within 24 hours of intimation
- Spare parts & consumables included under AMC (except any items specifically excluded)
- 5. Validity of AMC: 3 years from date of agreement

- The successful bidder shall execute a formal agreement within 15 days from acceptance.

- Payment will be made after each year's completion subject to satisfactory performance.
