Sri.Sarang S Kumar, Aparna, Pada - South, Lalaji (JN), Karunagappally, Kollam has been advised by KPSC (Advice No.60) to the post of Sub Inspector of Police (Trainee) in the Kerala Civil Police Cadre vide reference 1st cited and appointment order issued to him vide reference 2nd cited. As such, he was admitted for basic training at the Kerala Police Academy w.e.f 03.10.2018 as Sub Inspector of Police (Trainee) Cadet No.1281.

02. The Director, Kerala Police Academy, Thrissur as per the reference cited 3rd, has forwarded a representation of Sri.Sarang S Kumar, Sub Inspector (Trainee). In the representation, as per the reference cited 4th, he has informed that he wants to resign from the post of Sub Inspector of Police (Trainee) due to personal reasons. It is also reported that he has remitted the Bond amount of Rs.1,00,000/- (Rupees One Lakh only) being the penalty at Sub Treasury, Chavara, Kollam vide Chalan No. KL 0157 98333 2019 20M dated 06.03.2020 for leaving the department consequent to the request for resignation from the post of Sub Inspector (Trainee).

03. As per the reference cited 5th, the Director, Kerala Police Academy has also reported that he has been relegated to the next Batch (30th B) as he was absent for more than 51 days from the basis training. But the Sub Inspector (Trainee) has not still reported for training.

04. In the circumstances stated above, the request of Sri. Sarang S Kumar for resigning from the post of Sub Inspector of Police (Trainee) is hereby accepted. The Director, Kerala Police Academy is directed to clear all liabilities outstanding, if any, against him. He will not have any further claims to rejoin the post of Sub Inspector of Police (Trainee) under any circumstances.
