Last date for the receipt of tenders will be at 2.30 PM on 18-12-2021. Late tenders will not be accepted. The tenders will be opened at 3.30 PM on 18-12-2021 in the presence of such of the tenderers or their authorized representatives who may be present at that time. This will be followed by a technical evaluation of the samples, as well as by a financial evaluation of the technically qualified tenders by committees to be decided by the Director, Kerala Police Academy. All tenderers will have the opportunity of being present on all the three occasions.

1. Intending tenderers should quote the rate inclusive of all taxes. Tenderer should supply the required items as and when demanded by supply order from this office. In case the selected tenderer fails to provide the item, including of the specified quality, within the stipulated time frame, including grace period (if any), the tenderer will be blacklisted from participating in any tender for the next three years.
2. No representation for the enhancement of the price once accepted will be considered.
3. Any attempt on the part of tenderers or their agents to influence the officers concerned in their favour by personal canvassing will disqualify the tenderers.
4. Grade/Quality of Items may be clearly noted in the tender.
5. Special conditions if any, attended with the tenders of the tenderer will not be applicable to the contract.
6. If any license or permit is required, tenderer must specify in their tender and also state the authority to which application is to be made.
7. Withdrawal from the tender after it is accepted or failure to execute agreement within a period of 15 days from the date of acceptance of order will entail cancellation of the order forfeiting the EMD and supply being entrusted to another firm
