- 2. This tender is an e-Tender and is being published online through e-procurement portal of Government of Kerala (<u>www.etenders.kerala.gov.in</u>). Prospective bidders willing to participate in this tender shall necessarily register themselves with above mentioned e-procurement portal. The tender timeline is available in the critical date section of this tender and all corrigenda, if any, shall be published on www.etenders.kerala.gov.in and shall not be available elsewhere.

- Kerala Police reserves the right to change the scheduled dates with prior intimation to all bidders.
- 4. Any exemption in the Tender Fees shall be as per the rules in the 'Stores Purchase Manual of the Government of Kerala.
- 5. Any exemption in the Earnest Money Deposit shall be as per the rules in the 'Stores Purchase Manual of the Government of Kerala'. Please refer Clause 8.6 to 8.11 of this. Micro, Small & Medium Enterprises registered with the National Small Industries Corporation Limited, New Delhi and in respect of which competency certificates are issued by the Corporation will be exempted from payment of earnest money deposits. Micro, Small & Medium Enterprises having DGS &D Registration will also be exempted from payment of EMD.
- The Bid security (EMD) is required to protect the purchaser against risk of Bidder's conduct, which would warranty the forfeiture of bid security. The EMD of non-successful bidders will be returned.

Solution Requirements & Capabilities

Kerala Police has implemented Fortinet SD-WAN devices with NGFW/UTM (Next Generation Firewall/Unified Threat Management) security subscriptions across all Police Stations, Police Higher Offices and at State Data Centres, which host servers for major Police applications.

A high-end Fortinet SD-WAN device with NGFW/UTM subscription is required for installation at Police higher offices, particularly at Police Headquarters, which shall be in compliance with the existing SD-WAN solutions in Kerala Police. The NGFW/UTM shall include, but not limited to, the following security features: Application Control & Visibility, Intrusion Prevention System (IPS), Category based Web Filtering, Content filtering, DNS filtering, Anti-spam service, Deep Packet Inspection (DPI) service and Advanced Malware Protection including Anti-Virus, Mobile Malware service, Botnet IP/Domain Service, Content Disarm & Reconstruction (CDR), Sandbox service, Virus Outbreak Protection Service etc.

I. PRE-QUALIFICATION CONDITIONS:

- The Bidder shall be a reputed and authorized vendor or dealer of Fortinet OEM, who is having an Authorization Certificate from the OEM to participate in the tender floated by Kerala Police. Certificate from the OEM for sales and service need to be produced. The Authorization Form from OEM (MAF-Manufacturer Authorization Format) shall specifically mention the tender number and the same shall be submitted along with the technical bid. Otherwise, it will be treated as invalid.
- 2. The bidder shall have their own Office/Support Center functioning in Kerala. The documentary proof for the same must be enclosed along with the tender document.

- 3. The bidder shall have Average Annual Turnover of at least INR 1 Crore (One Crore) during the last three financial years (2020-21, 2021-22 & 2022-2023). This shall be supported by audited balance sheet and P&L sheet for all three financial years & certificate from the company secretary/Audit firm certifying the turnover amount.
- 4. The bidder shall have minimum Five (5) successful SDWAN with NGFW/UTM license deployments.
- 5. The bidder shall have successfully deployed a SD-WAN solution in at-least 500 branches in India at Govt./ Public Sector/ Private Sector/ Scheduled Commercial Banks or deployed SD-WAN at minimum 1000 branches globally.
- 6. The bidder shall have at-least Five certified engineers on Routing, Switching, VPN Tunnelling, Security area that they are bidding for. The documents for the same including bio-data, certification, experience etc., must be enclosed along with the tender document.
- 7. The bidder shall not have been blacklisted by Central Government or any State Government organization/ department in India at any point of time. A Self declaration letter signed by the Authorized signatory of the bidder shall be submitted.
- 8. The bidder shall have following certificates.

- (d) In the matter of purchase of Stores by the State Government Departments, Small Scale Industrial Units sponsored by the National Small Scale Industries Corporation Limited, New Delhi and in respect of which competency certificates are issued by the Corporation will be exempted from payment of Earnest Money Deposits and Security Deposits.
- (e) The exemption stipulated in clauses (b), (c) and (d), above will not however, apply to tenders for the supply of raw materials or dietary articles or supply of stores on rate or running contract basis.
- 5. The tenders will be opened on the appointed day and time in the office of the Inspector General of Police, State Crime Records Bureau, Police Headquarters, Vazhuthacaud, Thiruvananthapuram, in the presence of such of those tenderers or their nominees who may be present at that time.
- 6. If any tenderer withdraws from his tender before the expiry of the period fixed for keeping the rates firm for acceptance, the earnest money if any, deposited by him will be forfeited to Government or such action will be taken against him as Government think fit.
- 7. Tenderers shall invariably specify in their tenders the delivery conditions including the time required for the supply of articles tendered for.
- 8. (a) The tenderer shall dearly specify whether the articles offered bear Indian Standards Institution Certification Mark or not. In such cases, they shall produce copies of Certification mark along with their tender in support of it.
- (b) Tenderers shall clearly specify whether the goods are offered from indigenous sources, from imported stocks in India or from foreign sources to be imported under a license. Government reserves the right to reject offers for import of goods if the Import Trade Control Policy in force at the time of award of the contract prohibits or restricts such imports.
- 9. The final acceptance of the tenders rests entirely with the Government who do not bind themselves to accept the lowest or any tender. But the tenderers on their part should be prepared to carry out such portion of the supplies included in their tenders as may be allotted to them.
- 10. In the case of materials of technical nature the successful tenderer should be prepared to guarantee satisfactory performance for a definite period under a definite penalty.

- 11. Communication of acceptance of the tender normally constitutes a concluded contract. Nevertheless, the successful tenderer shall also execute an agreement for the due fulfillment of the contract within the period to be specified in the letter of acceptance. The contractor shall have to pay all stamp duty, lawyer's charges and other expenses incidental to the execution of the agreement. Failure to execute the agreement within the period specified will entail the penalties set out in Para 12 below.
- 12. (a) The successful tenderer shall, before signing the agreement and within the period specified in the letter of acceptance of his tender, deposit a sum equivalent to 5 per cent of the value of the contract as security for the satisfactory fulfillment of the contract less the amount of money deposited by him along with his tender. The amount of security may be deposited in the manner prescribed in clause 4 supra or in Government Treasury Savings Bank and the Pass Book pledged to Purchasing Officer or in Fixed Deposit receipts of State Bank of Travancore/State Bank of India endorsed in favour of the above officer. Letters of guarantee in the prescribed form for the amount of security from an approved Bank will also be considered enough at the discretion of Government. If the successful tenderer fails to deposit the security and execute the agreement as stated above, the earnest money deposited by him will be forfeited to Government and contract arranged elsewhere at the defaulter's risk and any loss incurred by Government on account of the purchase will be recovered from the defaulter who will, however, not be entitled to any gain accruing thereby. If the defaulting firm is a registered firm their registration is liable to be cancelled.
- (b) In cases where a successful tenderer, after having made partial supplies fails to fulfill the contracts in full, all or any of the materials not supplied may at the discretion of the Purchasing Officer, be purchased by means of another tender/quotation or by negotiation or from the next higher tenderer who had offered to supply already and the loss, if any, caused to the Government shall thereby together with such sums as may be fixed by the Government towards damages be recovered from the defaulting tenderer.
- (c) Even in cases where no alternate purchases are arranged for the materials not supplied, the proportionate portion of the security deposit based on the cost of the materials not supplied at the rate shown in the render of the defaulter shall be forfeited and balance alone shall be refunded.
- (d) If the contractor fails to deliver all or any of the stores or perform the service within the time/period(s) specified in the contract, the purchaser shall without prejudice to its other remedies under the contract, deduct from the contract price as liquidated damages, a sum equivalent to 0.5% or 1% of the delivered price of the delayed stores or unperformed services for each week of delay until actual delivery or performance, up to a maximum deduction of 10% of the contract prices of the delayed stores or services. Once the maximum is reached, the purchaser may consider termination of the contract at the risk and cost of the contractor.
- 13. The security deposit shall, subject to the conditions specified herein, be returned to the contractor within three months after the expiration of the contract, but in the event of any dispute arising between the Department concerned and the contractor, the Department shall be entitled to deduct out of the deposits or the balance thereof, until such dispute is determined the amount of such damages, costs, charges and expenses as may be claimed. The same may also be deducted

from any other sum, which may be due at any time from Government to the contractor. In all cases where there are guarantees for the goods supplied the security deposit will be realized only after the expiry of the guarantee period. If the Security deposit is not released even after the completion of one year, from the date of expiry of the period of contract provided there are no complaints against the contractor, interest at the rate of interest paid for S. B. Accounts by nationalized banks will be paid on the Security Deposit".

- 14. (a) All payments to the contractors will be made by the Purchasing officer in due course:-
 - (i) either by Departmental cheques payable at the Kerala Government Treasuries; or
- (ii) by cheques or drafts on the Reserve Bank of India, State Bank of India and State Bank of Travancore (at any of their Principal Branches in India).
- (iii) In the case of supplies from abroad by drafts as may be arranged between the contracting parties
- (b) All incidental expenses incurred by the Government for making payments outside the district in which the claim arises shall be borne by the contractor.
- 15. The tenderers shall quote also the percentage of rebate (discount) offered by them in case the payment is made promptly within fifteen days/within one month of taking delivery of stores.
- 16. Ordinarily payments will be made only after the supplies are actually verified and taken to stock but in exceptional cases, payments against satisfactory shipping documents including certificates of Insurance will be made up to 90 per cent of the value of the materials at the discretion of Government. Bank charges incurred in connection with payment against documents through bank will be to the account of the contractor. The firms will produce stamped pre-receipted invoices in all cases where payments (advance/final) for release of railway receipts/shipping documents are made through banks. In exceptional cases where the stamped receipts of the firm are not received for the payments (in advance) the unstamped receipt of the Bank (i.e., counterfoils of pay-in-slips issued by the Bank) alone may be accepted as a valid proof for the payment made.
- 17. The contractor shall not assign or make over the contract on the benefits or burdens thereof to any other person or body corporate. The contractor shall not underlet or sublet to any person or persons or body corporate the execution of the contract or any part thereof without the consent in writing of the purchasing officer who shall have absolute power to refuse such consent or to rescind such consent (if given) at any time if he is not satisfied with the manner in which the contract is being executed and no allowances or compensation shall be made to the contractor or the sub-contractor upon such rescission. Provided always that if such consent be given at any time, the contractor shall not be relieved from any obligation, duty or responsibility under this contract.
- 18. (a) In case the contractor becomes insolvent or goes into liquidation, or makes or proposes to make any assignment for the benefit of his creditors or proposes composition any with his creditors for the settlement his debts, carries on business his the or contract under inspection behalf of or his creditors, or in receiving case any orders, for the administration of his estate are made against him or in

the contractor shall commit any act of insolvency or in case in which clause any clauses of this contract contractor shall have rendered anv clause or clauses of this contract the contractor rendered himself shall have liable to damages amounting to the whole of his security deposits, the contract shall, thereupon, after notice given by the Purchasing Officer the contractor, determined be and the Department/Government may complete the contract such in time and manner and by such the persons as department/Government shall think fit. But such determination the of contract shall without prejudice to any any right or remedy of the Government against the contractor or his sureties in respect of any breach contract theretofore committed by the contractor. ΑII expenses damages caused to Government by any breach of contract by the contractor shall paid by the contractor to and may be recovered from him under Government, the provisions of the revenue Recovery Act in force in the State.

(b). The persons/contractors submitting tenders should produce a solvency certificate, clearly indicating to what extent they are solvent from the Tahsildar of the Taluk where they reside along with their tenders.

Note. - The solvency certificate referred to above will apply only in the case of supply of the following articles viz., dietary articles, fuels, raw materials like roots, creepers, flowers etc., and provisions to hospitals and hostels, sundry articles etc.

19. (a) In case the contractor fails to supply and deliver any of the said things within the time provided for delivery same, or of the case contractor commits any breach of any of the covenants, stipulations and agreements herein contained, and on his part to be observed performed, then and in any such case, it shall lawful for Government be shall think fit to do so) to arrange for the purchase of the said articles things from elsewhere or on behalf of the Government by an order in writing under the hand of the Purchasing Officer put an end to this contract and in case the Government shall have incurred, sustained or been put to any costs, damages or expenses by reason of such purchase or by reason of this contract having been so put an end to or in case any difference in price, compensation, loss costs, damages, expenses or other moneys shall then or any time during the continuance of this contract by payable by the contractor to the Government under and by virtue of this contract, it shall be lawful for the Government from and out of any moneys for the time being payable or owing to the contractor from the Government under or by virtue of this contract or otherwise to pay and reimburse to the Government all such costs, damages and expenses they may have sustained, incurred or been put to by reason of the purchase made elsewhere or by reason of this contract having been so put an end to as aforesaid and also all such difference in price, compensation, loss costs, damages, expenses, and other moneys as shall for the time being be payable by the contractor aforesaid.

- (b).In case any difference or dispute arises in connection with the contract, all legal proceedings relating to the matter shall be instituted in the Court within whose jurisdiction the Purchasing Officer voluntarily resides.
- 20. Any sum of money due and payable to the contractor (including security deposit returnable to him) under this contract may be appropriated by the Purchasing Officer or Government or any other person authorized by Government and set off against any claim of the Purchasing Officer or Government for the payment of a sum of money arising out of or under any other contract made by the contractor with the Purchasing Officer or Government or any other person authorized by Government. Any sum of money due and payable to the successful tenderer or contractor from Government shall be adjusted against any sum of money due to Government from him under any other contracts.
- 21. Every notice hereby required or authorized to be given may be either given to the contractor personally or left at his residence or last known place of abode or business, or may be handed over to his agent personally, or may be addressed to the contractor by post at his usual or last known place of abode or business and if so addressed and posted, shall be deemed to have been served on the contractor on the date on which, in the ordinary course of post, a letter so addressed and posted would reach his place abode or business.
- 22. The tenderer shall undertake to supply materials according to the standard sample and/or specifications.
- 23. (a) No representation for enhancement of rates once accepted will be considered. However, in exceptional cases if Government is convinced of any compelling need for enhancement of rate, it may do so.
- (b).In the case of imported goods, when the price accepted is the ex-site price quoted by the tenderer, the benefit of any reduction in the c.i.f. price should accrue to the purchasing department of Government.
- 24. Any attempt on the part of the tenderers or their agents to influence the department/Stores Purchase Department in their favour by personal canvassing with the Officers concerned will disqualify the tenderers.
- 25. Tenderers should be prepared to accept orders subject to the penalty clause for forfeiture of security in the event of default in supplies or failure to supply within the stipulated period.
- 26. Samples should be forwarded if called for and unapproved samples got back by the tenderers at their own cost. Samples sent by V. P. Post or 'freight to pay' will not be accepted. The approved samples may or may not be returned at the discretion of the undersigned. Sample sent by post, railway or plane should be so dispatched as to reach the Purchasing Officer not later than the date on which the tenders are due. In the case of samples sent by railway the receipt should be sent separately and not along with the tender since the tender will be opened only on the appointed day and demurrage will have to be paid if the railway parcels are not cleared in time.

Government will not be responsible if any sample if found missing at any time due to the nonobservance of the provisions of this clause. Tenderers whose samples are received late will not be considered. Samples should be forwarded under separate cover duly listed and the corresponding number of the item in the tender schedule should also be noted in the list of samples. Tenders for the supply of materials are liable to be rejected unless samples, if called for, of the materials tendered for are forwarded.

- 27. Telegraphic quotations will not be entertained.
- 28. (a) The prices quoted should be inclusive of all taxes, duties, cesses, etc., which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract.
- (b).In case payment of customs/excise duty is to be made by the Purchasing Officer; the Purchasing Officer will pay the duty on the "unloaded invoice price" only in the first instance, any difference being paid when the tenderer produces, the final assessment orders later.
- 29. The tenderer will invariably furnish the following certificate with their bills for payment. -

30. Special conditions, if any, of the tenderers attached with the tenders will not be applicable to the contract unless they are expressly accepted in writing by the purchaser.

31. (This applies only to the case of supply contracts where works such as erection and construction have also to be done. This may be scored out when not applicable). In the event of any question or dispute arising under these conditions or any special conditions of this contract or in connection with this contract the same shall be referred to the award of an arbitrator to be nominated by the purchasing officer and an arbitrator to be nominated by the contractor or in case of the said arbitrators not agreeing then to the award of an umpire to be appointed by the arbitrators in writing before proceeding on the reference and the decision of the arbitration or in the event of their not agreeing of the umpire appointed by them shall be final and conclusive and the provision of the Indian Arbitration Act, 1940 and of the rules there under and any statutory modifications thereof shall be deemed to apply to and be incorporated in this contract. Upon every and any such reference the assessment of the costs incidental to their reference and award respectively shall be in the discretion of the arbitrators or in the event of their not agreeing of the

umpire appointed by them. The venue of arbitration shall be the place from which the acceptance of tender is issued or such other place as the purchaser at his entire discretion may determine.

- 32. The tenderer should send along with his tender an agreement executed and signed in Kerala stamp Paper of value Rs. 500 purchased in the Kerala State. Stamp paper will be supplied to firms outside Kerala along with the tender forms on payment of Rs. 500 + Postage (Rs.500/-being the value of the stamp paper) which may be remitted by money order in advance. A specimen form of agreement is given as annexure to this tender. Tenders without the agreement in stamped paper will be rejected outright. But in deserving cases where agreement has not been received, the purchasing officer may exercise his discretion and call upon such tenderer to execute the agreement within a period of ten days from the date of issue of such intimation, if the purchasing officer is satisfied that the omission to forward the agreement along with the tender was due to cause beyond the control of the tenderer and was not due to any negligence on his part. Agreement received from a tenderer after the above time limit will not be considered.
- 33. The successful bidder shall have local presence in Kerala who shall be responsible for the servicing and maintenance of the equipment for 5 years.
- 34. The Security deposit/performance bank guarantee will be released only after satisfactory maintenance of the equipment for 5 year.
- 35. Intending Tenderers also may include charges for installation (of technical items), training of officers and on-site support at least for 5 years License and support in the Tenders.
