Late Tenders will not be accepted. The Tenders will be opened at the time mentioned above, in the presence of the tenderer or their authorized representatives (with proof of identity) who may be present at that time. The sale of tender form will be closed at 4.00 p.m. on 06.10.2020.

02. The tenders should be submitted in Aealed envelop clearly superscribed with 'Tender No. and name of item'. The rate is to be quoted in Indian Money. No advancepayment can be made for procuring any of the above items' .

03. Opening of tenders :- The offers received with requisite EMD or Bid security with samples will be opened on 07.10.2020 3.00 p.m in the presence of the representatives of the firms who may be present at that time. All tenders received without EMD will berejected outright. The bids will be evaluated by a Committee and those that do not conform to the specifications will be rejected. All prices quoted should be inclusive of alllevies and taxes. Customs duty if any should be mentioned specifically.

04. Intending Tenderer may, on application to the Director, Forensic Science Laboratory, Kerala obtain requisite tender forms on which the tenders should besubmitted or download the tender forms from the Kerala Police

05. Earnest Money Deposit (EMD) should be furnished along with the Tender. EMD may be submitted either in crossed Bank Drafts/ Treasury Savings Bank Deposits/ Government Promissory notes/ Bank Guarantee or National Saving Certificates drawn in favour of Director, Forensic Science Laboratory, Thiruvananthapuram, Kerala-695010. The name of the firm and tender number should be mentioned in the reverse side of the EMD and Tender cost. Firms which are exempted from furnishing EMD should produce a copy of relevant authorized document for verification. Without EMD, the tenders will be rejected.

06. Preference will be given to the products submitted by the manufacturer or their authorized dealers having authorization from the original equipment manufacturer. Similarly preference will be given to the Tenderer having experience of supplying similar/ same items to Govt. Departments or Organizations, for which the tenderer has to produce proof of purchase/ installation/ satisfaction of the customer.
