Any quotation received after the time fixed on the due date is liable to be rejected.

The maximum period required for completion of work should also be mentioned. Quotations not stipulating period of firmness and with price variation clause and/or 'subject to prior work 'condition are liable to be rejected.

Maximum Expected cost - Rs. 70,000/-

The acceptance of the quotations will be subject to the following conditions:

- 1. Withdrawal from the quotation after it is accepted or failure to complete the work within a specified time or according to standard will entail cancellation of the order and works being made at the offerers expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Government reserves also the right to remove the defaulter's name from the list of Government contractors permanently or for a specified number of years.
- 2. Any attempt on the part of tenderer or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the tenderer.
- 3. If any license or permit is required, tenderer must specify in their quotation and also state the authority to whom application is to be made.
- 4. The quotation may be for the entire works. But the tenders should be prepared to carry out such portion of the work included in their quotation as may be allotted to them.
- 5. The prices quoted should be inclusive of all taxes, duties, cess, etc, which are or may become payable by the contractor under existing or future laws or rules of the country.
- 6. The tenderer shall quote also the percentage of rebate (discount) offered by them in case the payment is made promptly within fifteen days/within one month of taking delivery of stores.
- 7. Special conditions, if any, printed on the quotation sheets of the tenderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the work.
- 8. **Quotations will be accepted only from GST-registered contractors.** The quoted amount should include GST rate (separately mentioned the GST).
- 9. The entire work shall be completed within three weeks from the date of receipt of the work order. Payment will be released on the basis of the completion certificate and valid GST invoice received from the SHO, Eloor Police Station.
