Sealed quotations are invited for construction of Septic Tank at Mattanchery housing complex, Kochi city. The rates quoted should be for the completion of the work at the place mentioned above. The necessary superscription, due date for the receipt of quotations, the date up to which the rates shall remain firm for acceptance, and the name and address of the officer to whom the quotation is to be sent are noted above. Any quotation received after the time fixed on the due date is liable to be rejected. The maximum period for completion of the work should also be mentioned. Quotations not stipulating the period of firmness and those containing a price variation clause and/or "subject to prior work" condition are liable to be rejected.

The acceptance of the quotations will be subject to the following conditions:

1. Withdrawal of the quotation after acceptance, or failure to complete the work within the specified time or according to specifications, will entail cancellation of the order and the work being arranged elsewhere at the tenderer's expense. Any loss

incurred thereby shall be payable by the defaulting party. In such an event, the Government also reserves the right to remove the defaulter's name from the list of Government suppliers permanently or for a specified period.

2. Any attempt on the part of the tenderer or their agents to influence the officers concerned in their favour through personal canvassing will disqualify the tenderer.
3. If any licence or permit is required, the tenderer must specify the same in the quotation and also state the authority to whom the application is to be made.
4. The quotation may be submitted for the entire work. However, the tenderers should be prepared to carry out such portion of the work included in their quotation as may be allotted to them.
5. The prices quoted should be inclusive of all taxes, duties, cess, etc., which are or may become payable by the contractor under existing or future laws or rules of the country.
6. Special conditions, if any, printed on the quotation sheets of the tenderer or attached to the tender shall not be applicable to the contract unless expressly accepted in writing by the department.
