- 2. No representation for enhancement of price once accepted will be considered.
- 3. Any attempt on the part of tenderers or their agents to influence the Officers





concerned in their favour by personal canvassing will disqualify the tenderers.

- 4. If a successful tenderer fails to fulfill the contracts in full after making partial supplies, the materials not supplied may be purchased from elsewhere (another tender/quotation, negotiation, or next higher tenderer). Any loss caused to the Government Railway Police, including damages, shall be recovered from the defaulting tenderer.
- 5. The prices quoted should be inclusive of all taxes, duties, cesses, etc.
- 6. Payments will be made only after the delivery of the items and the inspection of the same by a committee constituted by the Superintendent of Police Railways.
