The acceptance of the quotations will be subject to the following conditions:

1. Withdrawal from the quotation after it is accepted or failure to complete the work within a specified time or according to standard will entail cancellation of the order and works being made at the offerer's expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Government reserves also the right to remove the defaulter's name from the list of Government contractors permanently or for a specified number of years.
2. Any attempt on the part of tenderer or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the tenderer.
3. If any license or permit is required, tenderer must specify in their quotation and also state the authority to whom application is to be made.
4. The quotation should cover the entire work, including plumbing materials, labour charges, GST, and all other applicable charges. The contractors should be prepared to carry out any portion of the work included in their quotation that may be allotted to them
5. The prices quoted should be inclusive of all taxes, duties, cess, etc, which are or may become payable by the contractor under existing or future laws or rules of the country.
6. Special conditions, if any, printed on the quotation sheets of the tenderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the work.
7. Quotations will be accepted only from GST-registered contractors. The quoted amount should include GST rate (separately mentioned the GST).
- 8 . The entire work shall be completed within three weeks from the date of receipt of the work order. Payment will be released on the basis of the completion certificate and valid GST invoice received from the SHO,Ernakulam Central Police Station.
