Sub: Implementation of Physical Proficiency and Knowledge Proficiency Progress Cards (PPCs) in Basic Training Programme of Sub Inspector Trainees - Reg

In order to evaluate the progress in training of Recruit Sub Inspectors, undergoing their Basic Training especially with reference to improvement in their combat readiness and physical fitness, professional knowledge and skills and interpersonal abilities, it has been decided to introduce **Two Proficiency Progress Cards (PPCs)** one for Indoor Subjects and another for Outdoor Subjects.


