Sub:- Issuance of Police Clearance Certificate (PCC) - Reg.

The Police Clearance Certificate (PCC) is insisted by the authorities of UAE for those Indian nationals who intend to work in the UAE.

- **02.** Some instructions were issued relating to the issuance of PCC earlier. The instant instructions supersede them. A meeting was convened by the Chief Secretary to Government, attended by the ACS (Home & Vigilance), myself and the Secretary to the Hon'ble Chief Minister. First it was decided that, as envisaged in the government order, Rs.1,000/- will be charged for the issuance of PCC.
- **03.** This Police Clearance Certificate will be issued on the basis of the records available in the district and on the basis of declaration submitted by the applicant.
- **04.** A new format has been designed which is enclosed to this ED. This format shall only be used by the applicant to submit an application in a Police Station.
- **05.** Payment of Rs.1,000/- can be made through TR-5 Form or by online. The fund shall be kept in the TSB account, till the Government issue orders to remit the amount to the Treasury. The DPC concerned will make all such arrangements.
- **06.** The Police Station concerned of the applicant should be careful and prudent in the issuance of clearance regarding the criminal cases. If they have any doubt, they can contact other Police Station also. Similarly, District Special Branch also to be careful in checking the

criminal antecedents of the applicant for the entire District. They are also free to contact any Police Station anywhere in the State.

- **07.** The DPC will have to sign the PCC as is done and format of the PCC is also attached to this. While issuing PCC in this format, a copy of the application which contains the declaration of the applicant shall be attached to the PCC and it should be mentioned clearly in the PCC.
- **08**. Police Clearance Certificate to be issued as quickly as possible. DPCs can use technology for issuing PCCs.
