1. Rate should be all inclusive including cost of material, making charges, packing charges, transportation, handling charges, serving utensils, serving personnel etc for delivery, serving, closing and cleaning etc @ Rajagiri College, Kakkanad, Kochi.
2. Payment 100% against delivery, on the basis of certification of quality and quantity by the SPC Directorate.
3. The items shall be delivered on the stipulated time-frame of issue of purchase order @ SPC Directorate.
4. State Nodal Officer, Student Police Cadet Directorate, Thiruvananthapuram reserves the right to accept the whole quotations or any part thereof or reject all quotations without assigning any reasons.
5. The quotation will be finalized after considering the company profile, public acceptance and brand value of the tenderer in the field.
6. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offerors /expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Government reserves also the right to remove the defaulter's name from the list of Government suppliers permanently or for a specified number of years.
