Superscription: Quotation for Setting up of Badminton Court in Punalur Railway Police Station (Plot Leveling, Soil for side lining, Flood Light System and associated electrical works, Installation of Posts with nets)

Sealed quotations are invited for the work specified in the schedule attached above. The rates quoted should be for setting up of Badminton court in Punalur Railway Police Station. The necessary superscription, due date for the receipt of quotations, the date up to which the rates will have to remain firm for acceptance and the name and address of officer to whom the quotation is to be sent are noted above. Any quotation received after the time fixed as the due date is liable to be rejected. Quotations not stipulating a period of firmness and with price variation clause are liable to be rejected. The acceptance of the quotations will be subject to the following conditions:

 Acceptance of the quotation constitutes a concluded contract. Nevertheless, the successful tenderer must, within a fortnight/a month after the acceptance of his quotation, furnish 5 per cent of the amount of the contract as security deposit and execute an agreement at his own cost for the satisfactory fulfillment of the contract, if





so required.

- 2. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offerer's expenses from elsewhere, any loss incurred thereby being payable by the defaulting party.
- 3. No representation for enhancement of price once accepted will be considered during the currency of the contract.
- 4. Any attempt on the part of tenderers or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the tenderers.
- 5. If any license or permit is required, tenderers must specify it in their quotation and also state the authority to whom the application is to be made.
- 6. (a) If a successful tenderer fails to fulfill the contracts in full after making partial supplies, the materials not supplied may be purchased from elsewhere (another tender/quotation, negotiation, or next higher tenderer). Any loss caused to the Government Railway Police, including damages, shall be recovered from the defaulting tenderer. (b) Even if no alternate purchases are arranged, the proportionate portion of the security deposit based on the cost of the materials not supplied shall be forfeited, and the balance alone shall be refunded.
- 7. The prices quoted should be inclusive of all taxes, duties, cesses, etc.

8. Payments will be made only after the completion of work and the inspection of the same by a committee constituted by the Superintendent of Police Railways.
