1. Sealed Quotations must be submitted on or before 18-02-2026 before 11 PM to the office of the Commandant, SAP Battalion, Trivandrum, clearly superscribed as "Quotation for purchasing electrical items for police lines 10 building, SAP Bn."
2. The quotation should indicate the rate per unit, brand name, and total cost for each item (including all taxes, labour cost and delivery charges).
3. The materials supplied must be of standard quality and branded make. Local or substandard products will not be accepted.
4. The entire quantity must be delivered within 7 days from the date of issuing the supply order, at the battalion premises.
5. The supplier shall be responsible for the replacement of any damaged or substandard items found at the time of delivery.
6. The rate quoted shall be valid for a minimum of 30 days from the date of quotation opening.
7. No advance payment shall be made. Full payment will be released only after verification report.
8. The Commandant reserves the right to reject any or all quotations without assigning any reason whatsoever.
9. In case of delay in supply or deviation from the specifications, penalty may be imposed or quotation may be cancelled.
