Quotation Notice

Sealed quotations are invited for carrying out the repair/renovation of electrical wiring and plumbing works of Perumbavoor Police station and maintenance of toilets for visitors (Ladies & Gents) for the following specification. The quotation should contain total expenditure of the work including labour charge, taxes etc.

The quotation should be submitted in envelop bearing the name of the work and addressed to the District Police Chief, Ernakulam Rural. Intending suppliers shall submit their quotation in their own letter head

Any quotation received after the time fixed on the due date is liable to be rejected. The maximum period required for the completion of work should also be mentioned. The acceptance of the quotations will be subject to the following conditions :

1. Acceptance of the quotation constitutes a concluded contract. Nevertheless, the successful tenderer must within a fortnight after the acceptance of his quotation execute an agreement at his own cost for the satisfactory fulfillment of the contract, if so required.
2. No representation for enhancement of price once accepted will be considered during the current year of the contract.
3. If any license or permit is required, renderers must specify in their quotation and also state the authority to whom application is to be made.
4. Withdrawal from the quotation after it is accepted or failure to complete the work within a specified time or according to standard will entail cancellation of the order and works being made at the offerer's expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Government reserves also the right to remove the defaulter's name from the list of Government contractors permanently or for a specified number of years.
5. The prices quoted should be inclusive of all taxes, duties, Cess, etc., which are or may become

payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract 6.Special conditions, if any, printed on the quotation sheets of the tenderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the work.

7. The entire work shall be completed within Two weeks from the date of receipt of the work order. Payment will be released on the basis of the completion certificate from the officer concerned.
