Sealed Quotations are invited for the Supply of 3 KVA online UPS for the use of Cyber Crime Police Station, Kalpetta. The Quotation should contain price of the item including tax. The quotation should be submitted in envelop bearing the name of the item and addressed to District Police Chief, Kalpetta North, Wayanad, intending suppliers may submit the quotation in their own letter head along with TIN/CST/GSTIN number. Last date of receipt of quotation is on 10.12.2021 at 04.00 PM. Late quotations will not be acceptable. Payment will be made only after the verification of the supplied items. Advance payment will not be allowed. Approximate cost is Rs.90,000/- [Rupees Ninety Thousand only], including tax.

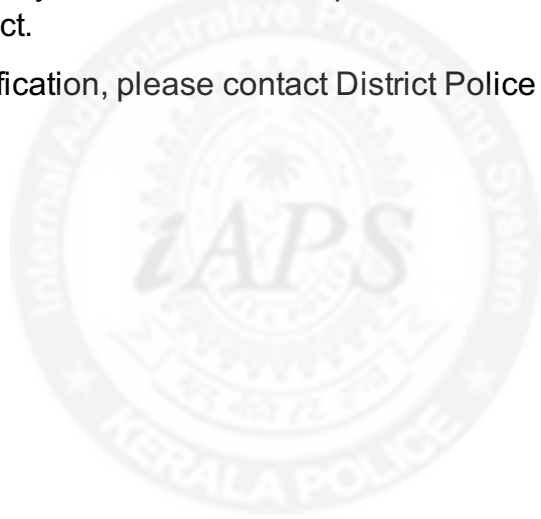

## **General Conditions**
