As per PHQ letter no. L3- 153446/2014/PHQ dated 23.02.2018 and E-7/213166/2016/PHQ dated 29.01.2018, the strength of Buglar PCs of this unit (Sanctioned strength of 09 Buglar PCs) is corrected as Buglar PCs 05 and Drummer PCs 04.

The existing strength of police constables (as on 01.03.2020) is 640 only against the sanctioned strength of 643. Also, Five RtPCs are under going recruit training and 08 candidates are ready (CES/ relegated/ retrenched/ crime case/ disciplinary action pending) for recruit training.
