Sub : Police Estt.-Retirement from service on superannuation for the period from 1/1/2020 to 30/6/2021 (18 months) – List publishing of – reg.

1. As per the directions contained in the Govt Order cited 2nd , the names of employees who are due to retire from service during 1/1/2020 to 30/6/2021 (18 months) are furnished below. They will retire from service with effect from the after noon of the last day of the month in which they attain the age of superannuation, as noted against their names. They will not be retained in service beyond that date.

2. All Officers are directed to verify the Date of Birth of all persons working under them with reference to their small service books etc. and corrections/omissions if any noted should be reported to this Office, IMMEDIATELY.

3 . If anyone is received on transfer from any other Units and if anyone is reinstated into service after suspension / dismissal and is found due for retirement on superannuation during 1/1/2020 to 30/6/2021 after the issue of this District Order ; their Name, Rank, Date of Birth etc. should be reported to this Office by the Officers concerned under whom he/she is working, without fail for verification and incorporation of their names.

4. All Officers should ensure that no person is in service beyond their retirement dates and that no one is excluded from the list. If anybody happens to be in service or draw and receive pay and allowances after their retirement, the concerned Officers/SHOs will be held personally responsible for the lapses. A report should be submitted to this Office immediately after the concerned is relieved off his duties on retirement.

5. A copy of this order should be got noticed by the respective persons under proper acknowledgement.

6.The pension applications should be submitted online through PRISM (Pensioner Information System) (Website- www.prism.kerala.gov.in) with 3 copies of identification particulars (page no. 33 of pension book).

7. Liabilities if any outstanding to Government from the retiring Officers should be assessed and reported to this Office sufficiently early to effect recovery in lump from their last pay. The ISHOs/SHOs/Unit Officers should assess and settle liabilities at least before 15 days prior to the date of retirement of the individuals as required in PHQ Circular No: 39/12.

8. On option, the retiring person can stop the subscription to GPF account within one year before their retirement. The subscriber to FBS is given option to remit the subscription in lump for the last six months prior to their retirement for the speedy settlement of the claim. The subscription to the State Life Insurance can also be made like this.

9. Concerned immediate supervisory Officers/SHOs should forward the (a) Liability/Non liability report & (b) No leave roll pending report to the District Police Office immediately after the date of retirement of employees concerned.

10. If this list is found correct, all SHOs/Officers furnish a certificate to this effect that 'the Date of Birth of all the Officers have been verified and there is no one to retire before 30/6/2021 except the persons shown below' should be submitted within 7 days.If any Officer due to retire from 1/1/2020 to 30/6/2021 and not included in the list, the same should be reported by return.


