**NOTIFICATION**

Pursuant to the directions contained in the **Special Rules** for the various categories of posts in Mounted Police Unit of the Kerala Police Subordinate Service published vide G.O (P) No. 50/2021/Home Dated 02/07/2021, it has been decided to fill up the existing vacancies in the cadre of Mounted Police Constable / Mounted Police Constable (Farrier) / Mounted Police Constable (Blacksmith) in Thiruvananthapuram City through By Transfer Appointment as specified below.

Name of post	Method of Appointment
Mounted Police Constable	(i) By transfer appointment from willing and qualified Police Constables/Civil Police Officers in the Armed Police Battalions/Kerala Civil Police and Police Constables( Farrier/Blacksmith) in the Mounted Police under the Kerala Police Subordinate Service, on the basis of seniority.
Mounted Police Constable (Farrier) / Mounted Police Constable (Blacksmith)	(i) By transfer appointment from willing and qualified Police Constables/Civil Police Officers in the Armed Police Battalions/Kerala Civil Police under the Kerala Police Subordinate Service, on the basis of seniority. (ii) By transfer appointment from willing and qualified Syce/Saddlers/Cobblers in the Mounted Police Unit, on the basis of seniority.

02. In the absence of qualified and willing hands, the vacancies in the cadre of above mentioned posts will be filled by direct recruitment as specified in the Special Rules.

03. In this regard, eligibility criteria for each category of posts are given below.

Name of Post	Educational Qualifications
Mounted Police Constable	(a) Must have passed Higher Secondary Examination or its equivalent. (b) Must be an approved probationer in the cadre of Police Constable/Civil Police Officer in the Armed Police Battalion/Kerala Civil Police. (c) Must have minimum one year experience in horse riding from a Firm/Sports Club having registration under State /Central Government or State Sports Council/Sports Authority of India.
Mounted Police Constable (Farrier)	(a) Must have passed Higher Secondary Examination or its equivalent. (b) Must be an approved probationer in the cadre of Police Constable/Civil Police Officer in the Armed Police Battalion/Kerala Civil Police. (c) Must have minimum one year experience as Farrier having acquired skill in horse's hoof care, trimming and balancing of hooves, placing of shoes on their hooves and fabricating of horse shoes from a Firm/Sports Club having registration under State /Central Government or State Sports Council/Sports Authority of India.

Mounted Police Constable (Blacksmith)	(a) Must have passed Higher Secondary Examination or its equivalent. (b) Must be an approved probationer in the cadre of Police Constable/Civil Police Officer in the Armed Police Battalion/Kerala Civil Police. (c) Must have National Trade Certificate in Blacksmith Trade. (c) Must have minimum one year experience as Blacksmith from a Firm/Institution having registration under State /Central Government.

04. The Unit Heads are directed to circulate the Notification among all the Police Personnel of the respective units, obtain applications from willing and qualified Police Personnel as specified in the Special Rules and furnish the same to this office. Wide publicity has to be given among all eligible Police Personnel and **they may be allowed to submit their applications till 20/09/2021 with all relevant documents to prove their qualifications.** Original documents may be verified and returned and attested copies are to be filed.

05. The unit heads will scrutinize the applications with regard to eligibility criteria mentioned in Special Rules and furnish details of eligible police personnel with date of declaration of probation and copies of Plus Two / Pre-degree Pass Certificate & Experience Certificate in respect of the applicants as specified in the Special Rules. **The details may be furnished in the Performa A after scrutiny by 25/09/2021 to this office.**
