Since required qualified & suitable applications have not been received for the Post of Clinical Psychologists, for conducting the written test & interview , it has been decided to relax only the experience & age limit as mentioned below.

(1) The Essential experience qualification has been revised as 1 year desirable experience in Internet/Digital De-addiction/sector/activities /projects. Hence the qualified Clinical Psychologists (Freshers) without experience can also apply for this Post .

(2) The Age limit set as 36 years as on 31/03/2022 in the original notification has been revised as 40 years, as on 31/03/2022.
