ORDER

As per the Government Orders read as first, second and third papers above 25% of the sanctioned strength of the post of Deputy Superintendent of Police are placed as Higher Grade in the scale of pay of Rs.77,400-1,15,200/-. The sanctioned strength of Deputy Superintendent of Police is 281. Hence 70 posts of Deputy Superintendent of Police can be placed as Deputy Superintendent of Police (Higher Grade).

2)The State Police Chief, Kerala in the letter read as 8th paper above has reported that only 69 officers are considered for placing as Deputy Superintendent of Police (Higher Grade) at present ie. one less than the required strength of Higher Grade Deputy Superintendent of Police.

3) The State Police Chief, Kerala as per the letter read as 8th paper above, has furnished proposal for placing the senior most officers included in the seniority list of Deputy Superintendent of Police read as 7th paper above as Deputy Superintendent of Police (Higher Grade) in the scale of pay of Rs.77,400-1,15,200/- in the existing vacancies including the one unfilled vacancy.

4) Government have examined the request in detail in view of the circular and Government Order read as 5th and 6th papers read above . Sri. V Madhosoodhanan (Sl No. 615 in the Seniority list of Deputy Superintendent of Police) is the junior most Higher Deputy Superintendent of Police has got the benefit of Higher Grade vide Government Order read as 4th paper above w e f 31.07.2019. In the circumstances Government are pleaded to order that the one unfilled vacancy is considered as arisen w.e.f **31.07.2019** ie. the date on which junior most Higher Deputy Superintendent of Police has got the benefit of Higher Grade promotion .

5) The senior most officer included in the seniority list of Deputy Superintendent of Police as per 7th paper above are considered for placing them as Deputy Superintendent of Police (Higher Grade) in the existing vacancies. As per the stipulations contained in the circular read as 5th paper above, only the officers who have satisfactorily completed the period of probation in the cadre of Deputy Superintendent of Police are eligible to be placed as Deputy Superintendent of Police (Higher Grade). On detailed examination, in the above said proposal the following officers may be excluded from sanctioning ratio based Higher Grade due to the reasons stated against their names

- 1) Sri M E Shajahan DySP (Sl No 578) Probation not declared.
- 2) Sri R Anilkumar DySP (Sl.No. 592) Probation not declared
- 3) Sri G S Sanalkumar, DySP (Sl No. 594) Probation not declared

4) Sri A Santhosh Kumar DySP (Sl No.(595) Probation not declared

6)In the circumstances stated above, Government are pleased to order that the following **14** officers in the cadre of Deputy Superintendent of Police are placed as Deputy Superintendent of Police (Higher Grade) in the scale of pay of Rs.77,400-1,15,200/- in the existing vacancies as detailed below on the condition that monetary benefit shall be admissible only for a maximum period of one year prior to the date of order of promotion vide KSR Part I Rule 23(d)
